## A BILL ENTITLED

1 AN ACT concerning

2 **Alcoholic Beverages – Harford County – License and Permit Fees and Repealing**  
3 **Obsolete Provisions**

4 FOR the purpose of repealing certain provisions relating to alcoholic beverages in Harford  
5 County; altering the fees for certain alcoholic beverages licenses and permits in  
6 Harford County; and generally relating to the regulation of alcoholic beverages in

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

8 That the Laws of Maryland read as follows:

9 **Article – Alcoholic Beverages**

11 (a) There is a Class A wine license in the County.

12 (b) The license may be issued to a holder of a Class 3 winery license or a Class 4  
13 limited winery license.

14 (c) (1) The license authorizes the license holder to sell at retail at the place  
15 described in the license wine produced at the winery that contains not more than 23% of  
16 alcohol by volume.

17 (2) Wine shall be sold in a sealed package or container that may not be  
18 opened or its contents consumed on the licensed premises.

19 (d) The annual license fee is \$100.]

21 (a) There is:

22 (1) a Class A beer and wine 6–day license; and

23 (2) a Class A beer and wine 7–day license.

24 (d) The annual license fees are:

28 (a) There is:

1 (1) a Class B-1 beer and wine 6-day license; and

2 (2) a Class B-1 beer and wine 7-day license.

5 (2) ~~[\$500]~~ **\$550** for a 7-day license.

18 (1) a Class C-1 beer and wine 6-day license; and

19 (2) a Class C-1 beer and wine 7-day license.

20 (c) The annual license fees are:

21 (1) ~~[\$150]~~ **\$200** for a 6-day license; and

22 (2) ~~[\$225]~~ **\$250** for a 7-day license.

23 22-806.

1 (a) There is:

2 (1) a Class C-2 beer and wine 6-day license; and

3 (2) a Class C-2 beer and wine 7-day license.

4 (c) The annual license fees are:

5 (1) [~~\$350~~] **\$400** for a 6-day license; and

6 (2) [~~\$425~~] **\$500** for a 7-day license.

7 22-807.

8 (a) There is:

9 (1) a Class C-3 beer and wine 6-day license; and

10 (2) a Class C-3 beer and wine 7-day license.

11 (c) The annual license fees are:

12 (1) [~~\$450~~] **\$500** for a 6-day license; and

13 (2) [~~\$525~~] **\$600** for a 7-day license.

15 (a) There is:

16 (1) a Class A-1 off-sale beer, wine, and liquor 7-day license; and

17 (2) a Class A-2 off-sale beer, wine, and liquor 6-day license.

18 (e) The annual license fees are:

19 (1) [~~\$1,470~~] **\$1,650** for a 7-day Class A-1 license; and

20 (2) [~~\$980~~] **\$1,100** for a 6-day Class A-2 license.

22 (a) There is:

23 (1) a Class B beer, wine, and liquor 6-day license; and

1 (2) a Class B beer, wine, and liquor 7-day license.

2 (g) (1) The annual license fees for a 6-day license are:

3 (i) [\$2,260] **\$2,500** for a hotel; and

4 (ii) [\$1,720] **\$1,900** for a restaurant.

5 (2) The annual license fees for a 7-day license are:

6 (i) [\$2,685] **\$3,000** for a hotel; and

7 (ii) [\$2,145] **\$2,400** for a restaurant.

8 (3) The annual license fees for an option to sell liquor for off-premises  
9 consumption are:

10 (i) \$350 for a 6-day restaurant; and

11 (ii) \$450 for a 7-day restaurant.

13 (a) There is:

14 (1) a Class B-3 restaurant/hotel 6-day license; and

15 (2) a Class B-3 restaurant/hotel 7-day license.

16 (g) (1) The annual license fees for a 6-day license are:

17 (i) [\$2,620] **\$2,900** for a hotel; and

18 (ii) [\$2,050] **\$2,300** for a restaurant.

19 (2) The annual license fees for a 7-day license are:

20 (i) [\$3,045] **\$3,350** for a hotel; and

21 (ii) [\$2,435] **\$2,700** for a restaurant.

22 (3) The annual license fees for an option to sell liquor for off-premises  
23 consumption are:

24 (i) \$350 for a 6-day restaurant; and

1 (ii) \$450 for a 7-day restaurant.

2 22-905.

3 (a) There is:

4 (1) a Class BFD (fine dining) beer, wine, and liquor 6-day license; and

5 (2) a Class BFD (fine dining) beer, wine, and liquor 7-day license.

6 (e) The annual license fees are:

7 (1) [~~\$2,500~~] **\$2,700** for a 6-day license; and

8 (2) [~~\$2,900~~] **\$3,200** for a 7-day license.

9 22-906.

10 (a) There is a Class BNR (newly opened restaurant) beer, wine, and liquor  
11 license.

12 (e) (1) The annual license fee is [~~\$3,000~~] **\$3,300**.

13 (2) Additional fees for Class B licenses with off-sale liquor privileges are:

14 (i) \$350, for a 6-day license; and

15 (ii) \$450, for a 7-day license.

16 22-907.

17 (a) There is:

18 (1) a 6-day Class C-1 (organization or club) beer, wine, and liquor license;  
19 and

20 (2) a 7-day Class C-1 (organization or club) beer, wine, and liquor license.

21 (e) (1) The annual fees for the 6-day license, depending on the size of the  
22 membership of the war veterans' organization, are:

23 (i) [~~\$350~~] **\$400**, for a membership of 50 to 99;

24 (ii) [~~\$600~~] **\$700**, for a membership of 100 to 250;

25 (iii) [~~\$850~~] **\$950**, for a membership of 251 to 450; and

1 (iv) ~~[\$1,000]~~ **\$1,100**, for a membership of at least 451.

2 (2) The annual fees for the 7-day license, depending on the size of the  
3 membership of the war veterans' organization, are:

4 (i) ~~[\$450]~~ **\$500**, for a membership of 50 to 99;

5 (ii) ~~[\$700]~~ **\$800**, for a membership of 100 to 250;

6 (iii) ~~[\$950]~~ **\$1,050**, for a membership of 251 to 450; and

7 (iv) ~~[\$1,100]~~ **\$1,250**, for a membership of at least 451.

8 22-908.

9 (a) There is:

10 (1) a 6-day Class C-2 (organization or club) beer, wine, and liquor license;  
11 and

12 (2) a 7-day Class C-2 (organization or club) beer, wine, and liquor license.

13 (e) (1) The annual fees for the 6-day license, depending on the size of the  
14 membership of the fraternal organization, are:

15 (i) ~~[\$800]~~ **\$900**, for a membership of 100 to 250;

16 (ii) ~~[\$1,050]~~ **\$1,200**, for a membership of 251 to 450; and

17 (iii) ~~[\$1,200]~~ **\$1,350**, for a membership of at least 451.

18 (2) The annual fees for the 7-day license, depending on the size of the  
19 membership of the fraternal organization, are:

20 (i) ~~[\$900]~~ **\$1,000**, for a membership of 100 to 250;

21 (ii) ~~[\$1,150]~~ **\$1,300**, for a membership of 251 to 450; and

22 (iii) ~~[\$1,300]~~ **\$1,450**, for a membership of at least 451.

23 22-909.

24 (a) There is:

1 (1) a 6-day Class C-3 (country club, topiary garden, or yacht or boat club)  
2 beer, wine, and liquor license; and

3 (2) a 7-day Class C-3 (country club, topiary garden, or yacht or boat club)  
4 beer, wine, and liquor license.

5 (e) (1) The annual fee for the 6-day license is [~~\$1,300~~] **\$1,450**.

6 (2) The annual fee for the 7-day license is [~~\$1,400~~] **\$1,550**.

7 22-910.

8 (a) There is:

9 (1) a Class D beer, wine, and liquor (on-sale) 7-day license; and

10 (2) a Class D beer, wine, and liquor (on- and off-sale) 7-day license.

11 (g) The annual license fees are:

12 (1) [~~\$3,000~~] **\$3,300** for an on-sale license; and

13 (2) [~~\$4,000~~] **\$4,400** for an on- and off-sale license.

14 22-1001.

15 (a) There is a Class B-BB (bed and breakfast) beer, wine, and liquor license.

16 (i) The annual license fee is [~~\$1,000~~] **\$1,100**.

17 22-1002.

18 (a) There is a Class CCFA (continuing care facility for the aged) beer, wine, and  
19 liquor license.

20 (e) The annual license fee is [~~\$5,000~~] **\$5,500**.

21 22-1003.

22 (a) There is a Class GC (golf course) beer, wine, and liquor license.

23 (e) The annual license fee is [~~\$3,500~~] **\$3,850**.

24 22-1004.



1 (a) There is a Class H–CC (corporate club/conference center) beer, wine, and  
2 liquor license.

3 (e) The annual license fee is [~~\$3,000~~] **\$3,300**.

4 22–1005.

5 (b) There is a Class B (inn) beer, wine, and liquor license.

6 (k) The annual license fee is:

7 (1) [~~\$2,500~~] **\$2,750** for an inn that has at least 11 but not more than 24  
8 rooms or suites; and

9 (2) [~~\$3,295~~] **\$3,650** for an inn that has at least 25 rooms or suites.

10 22–1006.

11 (b) There is a stadium beer, wine, and liquor license.

12 (g) The annual license fee is [~~\$10,000~~] **\$11,000**.

13 22–1201.

14 (a) There is a Class H caterer’s beer, wine, and liquor license.

15 (e) The annual license fee is [~~\$1,500~~] **\$1,650**.

16 22–1301.

17 (a) The following sections of Title 4, Subtitle 12 (“Temporary Licenses”) of  
18 Division I of this article apply in the County without exception or variation:

19 (1) § 4–1202 (“Per diem licenses”);

20 (2) § 4–1203 (“Class C per diem beer and Class C per diem beer and wine  
21 licenses”);

22 (3) § 4–1204 (“Class C per diem beer, wine, and liquor license”);

23 (4) § 4–1206 (“License to dispose of stock”);

24 (5) § 4–1207 (“Temporary move of licensed premises”); **AND**

25 (6) § 4–1208 (“Hours and days of sale”); and

1 (7) § 4-1209 (“Wine permit for fund-raising event”)].

2 (b) Section 4-1205 (“License fees”) of Division I of this article does not apply in  
3 the County and is superseded by § 22-1309 of this subtitle.

4 (C) SECTION 4-1209 (“WINE PERMIT FOR FUND-RAISING EVENT”) OF  
5 DIVISION I OF THIS ARTICLE APPLIES IN THE COUNTY, SUBJECT TO § 22-1312 OF  
6 THIS SUBTITLE.

8 (a) There is a wine festival (WF) license.

9 (b) The Board may issue the license to a holder of a retail license, Class 3 winery  
10 license, or Class 4 limited winery license.

11 (c) The license authorizes the holder to display and sell wine that is produced and  
12 processed in the State.

13 (d) A license holder shall display and sell wine:

14 (1) at retail for on- and off-premises consumption; and

15 (2) during the hours and days designated for the wine festival.

16 (e) The Board shall choose a location that is not already licensed.

17 (f) The license holder may hold another license of a different class or nature.

18 (g) The license fee is \$20.

19 (h) The Board shall adopt regulations to carry out this section.]

20 22-1309.

21 (a) The fee for a Class C per diem beer license or a Class C per diem beer and  
22 wine license is [~~\$15~~] **\$50** per day.

23 (b) The fee for a Class C per diem beer, wine, and liquor license is [~~\$30~~] **\$50** per  
24 day.

25 22-1310.

26 (a) (1) The Board may issue a Class C-3 multiple event (on-sale) beer, wine,  
27 and liquor license.

1           (2)    The license entitles a club to sell or provide beer, wine, and liquor for  
2 on-premises consumption by:

3                   (i)    nonmembers of the club who have leased an area of the licensed  
4 premises for entertainment, a conference, or a social event; and

5                   (ii)   guests who attend the event.

6           (3)    This section does not prohibit a club from obtaining a Class C per diem  
7 license.

8           (d)    The annual license fees are:

9                   (1)    ~~[\$250]~~ **\$300** for not more than 10 events per year;

10                  (2)    ~~[\$400]~~ **\$450** for not more than 20 events per year;

11                  (3)    ~~[\$550]~~ **\$650** for not more than 30 events per year;

12                  (4)    ~~[\$700]~~ **\$800** for not more than 40 events per year; and

13                  (5)    ~~[\$850]~~ **\$950** for not more than 60 events per year.

14   22-1311.

15           (a)    The Board may issue to a fire department a multiple event beer and wine  
16 license.

17           (e)    The annual license fees are:

18                  (1)    ~~[\$150]~~ **\$200** for not more than 10 events per year;

19                  (2)    ~~[\$300]~~ **\$350** for not more than 20 events per year;

20                  (3)    ~~[\$450]~~ **\$500** for not more than 30 events per year; and

21                  (4)    ~~[\$600]~~ **\$700** for not more than 40 events per year.

22   22-1312.

23           (A)    **THIS SECTION APPLIES TO A WINE PERMIT FOR A FUND-RAISING EVENT**  
24 **IN THE COUNTY.**

25           (B)    **THE FEE FOR A WINE PERMIT FOR A FUND-RAISING EVENT IS \$50.**

1           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
2 1, 2016.
