A BILL ENTITLED

1 AN ACT concerning

2 **Local Government Tort Claims Act – Regional Development Councils**

3 FOR the purpose of altering the definition of a “local government” under the Local
4 Government Tort Claims Act to include certain regional development councils;
5 providing for the application of this Act; and generally relating to the inclusion of
6 certain regional councils under the Local Government Tort Claims Act.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Courts and Judicial Proceedings**

15 5–301.

16 (a) In this subtitle the following words have the meanings indicated.

17 (b) “Actual malice” means ill will or improper motivation.

18 (c) (1) “Employee” means any person who was employed by a local government
19 at the time of the act or omission giving rise to potential liability against that person.

20 (2) “Employee” includes:

21 (i) Any employee, either within or without a classified service or
22 merit system;

1 (ii) An appointed or elected official; or

2 (iii) A volunteer who, at the request of the local government, and
3 under its control and direction, was providing services or performing duties.

4 (d) "Local government" means:

5 (1) A charter county as defined in § 1–101 of the Local Government Article;

6 (2) A code county as defined in § 1–101 of the Local Government Article;

7 (3) A board of county commissioners;

8 (4) Baltimore City;

9 (5) A municipality as defined in § 1–101 of the Local Government Article;

10 (6) The Maryland–National Capital Park and Planning Commission;

11 (7) The Washington Suburban Sanitary Commission;

12 (8) The Northeast Maryland Waste Disposal Authority;

13 (9) A community college or board of trustees for a community college
14 established or operating under Title 16 of the Education Article, not including Baltimore
15 City Community College;

16 (10) A county public library or board of trustees of a county public library
17 established or operating under Title 23, Subtitle 4 of the Education Article;

18 (11) The Enoch Pratt Free Library or Board of Trustees of the Enoch Pratt
19 Free Library;

20 (12) The Washington County Free Library or the Board of Trustees of the
21 Washington County Free Library;

22 (13) A special taxing district;

23 (14) A nonprofit community service corporation incorporated under State
24 law that is authorized to collect charges or assessments;

25 (15) Housing authorities created under Division II of the Housing and
26 Community Development Article;

1 (16) A sanitary district, sanitary commission, metropolitan commission, or
2 other sewer or water authority established or operating under public local law or public
3 general law;

6 (18) The Howard County Economic Development Authority;

7 (19) The Howard County Mental Health Authority;

8 (20) A commercial district management authority established by a county
9 or municipal corporation if provided under local law;

10 (21) The Baltimore City Police Department;

11 (22) A regional library resource center or a cooperative library corporation
12 established under Title 23, Subtitle 2 of the Education Article;

13 (23) Lexington Market, Inc., in Baltimore City;

14 (24) The Baltimore Public Markets Corporation, in Baltimore City;

15 (25) The nonprofit corporation serving as the local public transportation
16 authority for Carroll County pursuant to a contract or memorandum of understanding with
17 Carroll County (Carroll County Senior Overland Service, Inc., t/a Carroll Area Transit
18 System);

19 (26) The nonprofit corporation serving as the animal control and licensing
20 authority for Carroll County pursuant to a contract or memorandum of understanding with
21 Carroll County (the Humane Society of Carroll County, Inc.);

22 (27) Garrett County Municipalities, Inc., in Garrett County;

23 (28) The nonprofit corporation serving as the local public transportation
24 authority for Garrett County pursuant to a contract or memorandum of understanding with
25 Garrett County (Garrett County Community Action Committee, Inc.); and

26 (29) The nonprofit corporation serving as the industrial development
27 authority of Carroll County established under Title 12, Subtitle 1 of the Economic
28 Development Article.

29 **(E) (1) "REGIONAL DEVELOPMENT COUNCIL" MEANS A REGIONAL OR**
30 **MUNICIPAL COUNCIL ESTABLISHED UNDER TITLE 13 OF THE ECONOMIC**
31 **DEVELOPMENT ARTICLE.**

- 1 **(2) “REGIONAL DEVELOPMENT COUNCIL” INCLUDES:**
- 2 **(I) THE BALTIMORE METROPOLITAN COUNCIL;**
- 3 **(II) THE MID-SHORE REGIONAL COUNCIL;**
- 4 **(III) THE UPPER SHORE REGIONAL COUNCIL;**
- 5 **(IV) THE TRI-COUNTY COUNCIL FOR THE LOWER EASTERN**
6 **SHORE OF MARYLAND;**
- 7 **(V) THE TRI-COUNTY COUNCIL FOR SOUTHERN MARYLAND;**
8 **AND**
- 9 **(VI) THE TRI-COUNTY COUNCIL FOR WESTERN MARYLAND.**

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to
11 apply only prospectively and may not be applied or interpreted to have any effect on or
12 application to any cause of action arising before the effective date of this Act.

13 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
14 1, 2016.
