4 (g) (1) This section does not apply to the vehicles described in subsection (a)(1), 5 (4), and (5) of this section, at any railroad grade crossing in a business district or residential 6 district.

7 (2) This section does not apply to school buses and church buses, as 8 described in subsection (a)(2) and (3) of this section, at locations within Baltimore City 9 where complying with the provision of this section would conflict with the existing traffic 10 signal indications.

(3) THIS SECTION DOES NOT APPLY TO THE VEHICLES DESCRIBED IN SUBSECTION (A) OF THIS SECTION, AT ANY RAILROAD GRADE CROSSING WITH AN EXEMPT HIGHWAY-RAIL GRADE CROSSING PLAQUE.
