A BILL ENTITLED

1 AN ACT concerning

Seed Community Development Anchor Institution Fund

3 FOR the purpose of establishing the Seed Community Development Anchor Institution 4 Fund as a special, nonlapsing fund; specifying the purpose of the Fund; requiring the $\mathbf{5}$ Department of Housing and Community Development to administer the Fund; 6 requiring the State Treasurer to hold the Fund and the Comptroller to account for 7 the Fund; specifying the contents of the Fund; specifying the purpose for which the 8 Fund may be used; specifying certain eligibility criteria and a certain process for 9 awarding grants and loans from the Fund; providing for the investment of money in 10 and expenditures from the Fund; requiring interest earnings of the Fund to be 11 credited to the Fund; beginning in a certain fiscal year, requiring the Governor to 12include in the annual budget bill an appropriation of a certain amount to the Fund; 13exempting the Fund from a certain provision of law requiring interest on State 14 money in special funds to accrue to the General Fund of the State; defining certain 15terms; and generally relating to the Seed Community Development Anchor 16 Institution Fund in the Department of Housing and Community Development.

1 (B) THERE IS A SEED COMMUNITY DEVELOPMENT ANCHOR INSTITUTION 2 FUND.

3 (C) THE PURPOSE OF THE FUND IS TO PROVIDE GRANTS AND LOANS TO 4 ANCHOR INSTITUTIONS FOR COMMUNITY DEVELOPMENT PROJECTS IN BLIGHTED 5 AREAS OF THE STATE.

6 (D) THE DEPARTMENT SHALL ADMINISTER THE FUND.

7 (E) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT 8 SUBJECT TO § 7–302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

9 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY, 10 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

- 11 (F) THE FUND CONSISTS OF:
- 12 (1) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND;
- 13 (2) INTEREST EARNINGS OF THE FUND; AND

14(3) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR15THE BENEFIT OF THE FUND.

16 (G) (1) THE FUND MAY BE USED ONLY TO PROVIDE GRANTS AND LOANS 17 TO ANCHOR INSTITUTIONS FOR COMMUNITY DEVELOPMENT PROJECTS IN 18 BLIGHTED AREAS OF THE STATE.

19(2)TO BE ELIGIBLE FOR A GRANT OR LOAN, AN ANCHOR INSTITUTION20SHALL PROVIDE EVIDENCE OF MATCHING FUNDS FROM A PRIVATE SOURCE.

21 (3) THE DEPARTMENT SHALL AWARD GRANTS AND LOANS FROM THE 22 FUND ON A COMPETITIVE BASIS.

23 (H) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND 24 IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.

25(2)ANY INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO26THE FUND.

27 (I) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE 28 WITH THE STATE BUDGET.

1 (J) FOR FISCAL YEAR 2018 AND EACH FISCAL YEAR THEREAFTER, THE 2 GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF 3 \$10,000,000 TO THE FUND.
