#### **Construction Education and Innovation - Establishment of Fund**

This bill establishes the Construction Education and Innovation Fund to be administered by, and support the purposes of, the Maryland Center for Construction Education and Innovation (MCCEI). The bill requires the Governor to appropriate \$250,000 annually in the State budget to the fund beginning in fiscal 2018.

### **Fiscal Summary**

**State Effect:** General fund expenditures increase by \$250,000 beginning in FY 2018, which reflects the bill's mandated appropriation to the fund. Special fund revenues and expenditures increase by corresponding amounts each year. **This bill establishes a mandated appropriation beginning in FY 2018.**

Local Effect: None.

**Small Business Effect:** Minimal. Small businesses in the construction industry may continue to benefit from the center's efforts.

### **Analysis**

Current Law/Background: MCCEI is a public-private partnership located at Towson University that was established in 2010. It resulted from work performed by the Center for Industry Initiatives for Construction of the Governor's Workforce Investment Board (GWIB), which had convened a forum of industry stakeholders. GWIB provided MCCEI with grant funding of \$225,000 in each of fiscal 2013, 2014, and 2015, but GWIB ended its support for MCCEI after that. Currently, the center operates primarily with non-State revenues and contributions; Towson University provides office space for the center on an in-kind basis. MCCEI now identifies itself as an industry-led workforce intermediary that was established to create a world-class education system for Maryland's built environment. Its current staff consists of an executive director and a communications coordinator.

The fiscal 2017 State budget, as enacted, restricts \$250,000 for MCCEI as part of a larger package of \$80.0 million in restricted funds. The budget requires that the Governor transfer all, or none, of the restricted funds to their designated purposes, but the Governor may not elect to transfer only some of the restricted funds. If the Governor elects to transfer all of the restricted funds, MCCEI receives \$250,000 in fiscal 2017 in addition to the mandated appropriations to the Construction Education and Innovation Fund beginning in fiscal 2018.
