#### Somerset County - Commissioners - Salary and Expense Reimbursements

This bill increases the annual salary for the Somerset County commissioners from \$7,500 to \$8,500 and from \$8,500 to \$9,500 for the commission president. The bill also increases from \$2,500 to \$3,000 the annual reimbursement amount that commissioners may receive for expenses incurred for any official duties.

#### **Fiscal Summary**

State Effect: None.

**Local Effect:** Somerset County expenditures increase by \$4,900 in FY 2019 and by \$8,400 annually beginning in FY 2020. County revenues are not affected.

Small Business Effect: None.

## **Analysis**

**Current Law:** Salary adjustments for elected officials take effect at the beginning of the next term of office, which is December 2018 for the Somerset County commissioners. There are five county commissioners for Somerset County (four members and a president), each holding the position for a four-year term.

**Background:** Chapter 372 of 2007 increased the annual salary of the Somerset County commissioners and the members of the Somerset County Roads Board from \$6,000 to \$7,500. The salary for the commission president was increased from \$6,000 to \$8,500. Chapter 262 of 2001 increased the annual salary for commission and road board members

from \$5,500 to \$6,000. **Exhibit 1** shows the fiscal 2016 salaries for county council and commission members in selected Eastern Shore counties.

**Local Fiscal Effect:** Somerset County expenditures increase by \$4,916 in fiscal 2019 for increased salaries (\$2,917), fringe benefits (\$541), and expense reimbursements (\$1,458). This estimate reflects the additional personnel cost for the seven-month period from December 2018 through June 2019. Beginning in fiscal 2020, county expenditures increase by \$8,428 annually for salaries (\$5,000), fringe benefits (\$928), and expense reimbursements (\$2,500). This estimate assumes a constant fringe benefits rate of 18.6% as advised by the county.
