# FISCAL AND POLICY NOTE Third Reader - Revised

#### **Cecil County - Sheriff - Salary**

This bill sets the Cecil County Sheriff's salary at an amount not less than \$100,000, as determined by the Cecil County Council for the Sheriff's term of office that begins in fiscal year 2019.

## **Fiscal Summary**

**State Effect:** None.

**Local Effect:** Cecil County expenditures increase by at least \$14,200 in FY 2019 and by at least \$24,400 annually beginning in FY 2020. County revenues are not affected.

**Small Business Effect:** None.

## **Analysis**

**Current Law:** The current annual salary of the Cecil County Sheriff is \$75,075. The salary is scheduled to increase to \$82,075 beginning in fiscal 2019. Salary adjustments for constitutional officers take effect at the beginning of the next term of office, which for the Cecil County Sheriff is December 2018.

**Background:** Chapter 206 of 2014 increased the salary of the Cecil County Sheriff from \$71,500 to \$75,075 in fiscal 2016. Annual salary increases of 3% were provided until the sheriff's salary reaches \$82,075 in fiscal 2019. **Exhibit 1** shows the fiscal 2016 salaries for sheriffs in selected Maryland counties.

**Local Fiscal Effect:** Cecil County expenditures increase by at least \$14,214 in fiscal 2019 for salary (\$10,456) and fringe benefits (\$3,758). This estimate reflects the additional personnel cost for the seven-month period from December 2018 through June 2019. Beginning in fiscal 2020, county expenditures increase by at least \$24,367 annually for salary (\$17,925) and fringe benefits (\$6,442). This estimate assumes a constant fringe benefits rate of 35.94% as advised by the county and a \$100,000 annual salary.
