#### **Carroll County - Alcoholic Beverages Licenses - Beginning Hour of Sale**

This bill alters the hours during which holders of various beer and wine (BW) and beer, wine, and liquor (BWL) licenses in Carroll County may sell or provide alcoholic beverages for on- or off-premises consumption.

The bill takes effect July 1, 2016.

## **Fiscal Summary**

State Effect: None.

**Local Effect:** Minimal impact on Carroll County finances and operations. Compliance and enforcement activities relating to the new hours of sale can be handled with existing resources.

**Small Business Effect:** Minimal overall, but potential meaningful for businesses that are able to open earlier on Sundays and realize increased sales as a result.

#### **Analysis**

**Bill Summary/Current Law:** The hours that specified licensees in Carroll County are authorized to sell alcoholic beverages under the bill and under current law are described in **Exhibit 1**.
