AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Waldstreicher" and substitute "<u>Waldstreicher, Patterson, Tarlau, and M. Washington</u>"; in lines 2 and 28, in each instance, strike "Maryland Extended Day and Summer Enhancement Programs" and substitute "<u>Public School Opportunities Enhancement</u>"; in lines 3 and 10, in each instance, strike "Maryland Extended Day and Summer" and substitute "<u>Public School Opportunities</u>"; in line 4, strike "(Department)"; strike beginning with "education" in line 13 down through "agencies" in line 14 and substitute "<u>school systems, certain community schools,</u>"; in line 15, strike "or" and substitute a comma; and in the same line, after "partnerships" insert "<u>, or to expand or support certain educational programming during the school day</u>".

On page 2, strike beginning with "Maryland" in line 9 down through "Summer" in line 10 and substitute "<u>Public School Opportunities</u>".

AMENDMENT NO. 2

On page 2, strike beginning with "MARYLAND" in line 20 down through "PROGRAM" in line 21 and substitute "<u>PUBLIC SCHOOL OPPORTUNITIES</u> <u>ENHANCEMENT PROGRAM</u>"; after line 24, insert:

"(B) "COMMUNITY SCHOOL" MEANS AN EXISTING PUBLIC SCHOOL IN THE STATE THAT UTILIZES A COMMUNITY SCHOOL STRATEGY THAT IS RECOGNIZED BY THE MARYLAND OUT OF SCHOOL TIME NETWORK.";

in lines 25 and 26, in each instance, strike "**PROGRAMS**" and substitute "<u>**PROGRAM**</u>"; in lines 25 and 31, strike "(**B**)" and "(**C**)", respectively, and substitute "<u>(**C**)</u>" and "<u>(**D**)</u>", respectively; in line 25, after "**MEANS**" insert "<u>**AN**</u>"; in line 27, strike "**TAKE**" and

substitute "<u>TAKES</u>"; in line 31, strike "OR" and substitute "<u>, A COMMUNITY SCHOOL</u>, <u>OR A</u>"; and in line 32, strike beginning with "MARYLAND" through "SUMMER" and substitute "<u>PUBLIC SCHOOL OPPORTUNITIES</u>".

On page 2 in line 31, on page 5 in line 5, and on page 7 in line 1, in each instance, strike "EDUCATION AGENCY" and substitute "<u>SCHOOL SYSTEM</u>".

On page 3, in lines 1, 3, and 5, strike "(D)", "(E)", and "(F)", respectively, and substitute "(E)", "(F)", and "(G)", respectively; and in lines 3 and 16, in each instance, strike "MARYLAND EXTENDED DAY AND SUMMER" and substitute "<u>PUBLIC</u> <u>SCHOOL OPPORTUNITIES</u>".

On page 4, in line 26, strike "MARYLAND EXTENDED DAY AND SUMMER" and substitute "PUBLIC SCHOOL OPPORTUNITIES".

AMENDMENT NO. 3

On page 4, in line 29, strike "LOCAL EDUCATION AGENCIES" and substitute ":

(I) LOCAL SCHOOL SYSTEMS, COMMUNITY SCHOOLS,";

in line 30, after "ORGANIZATIONS" insert "<u>IN THE STATE</u>"; and in line 31, after "PROGRAMS" insert "<u>; AND</u>

(II) NONPROFIT ORGANIZATIONS IN THE STATE AND COMMUNITY SCHOOLS IN EXPANDING OR SUPPORTING EXISTING EDUCATIONAL PROGRAMMING DURING THE SCHOOL DAY".

On page 5, in line 1, after "(2)" insert "(I)"; in lines 3 and 4, strike "(I)" and "(II)", respectively, and substitute "<u>1</u>." and "<u>2</u>.", respectively; after line 4, insert:

"(II) WHEN AWARDING GRANTS TO NONPROFIT ORGANIZATIONS, THE DEPARTMENT SHALL GIVE PRIORITY TO MARYLAND-BASED NONPROFIT ORGANIZATIONS.";

in line 5, before "OR" insert "<u>, COMMUNITY SCHOOL</u>,"; after line 20, insert:

"(2) <u>A NONPROFIT ORGANIZATION MAY APPLY TO THE</u> <u>DEPARTMENT FOR A GRANT TO SUPPORT EXISTING EDUCATIONAL</u> <u>PROGRAMMING DURING THE SCHOOL DAY.</u>";

strike beginning with "EXTENDED" in line 25 down through "PROGRAMS" in line 26 and substitute "<u>THE SERVICES LISTED IN SUBSECTION (C) OF THIS SECTION</u>"; and in line 21, strike "(2)" and substitute "<u>(3)</u>".

AMENDMENT NO. 4

(IV) FOR EDUCATIONAL PROGRAMMING DURING THE SCHOOL DAY, ENHANCE:

<u>1.</u> THE EDUCATIONAL PURPOSE OF THE SCHOOL; OR

2. <u>Students' access to physical, social, and</u> <u>Emotional support</u>";
