"(B) IN ACCORDANCE WITH A COLLECTIVE BARGAINING AGREEMENT EXECUTED UNDER TITLE 6, SUBTITLE 4 OR SUBTITLE 5 OF THIS ARTICLE, OR AN AMENDMENT TO AN EXISTING AGREEMENT, A PRINCIPAL AND A TEACHER WHO ARE IN MUTUAL AGREEMENT OR A COUNTY BOARD MAY ADMINISTER A STATEWIDE KINDERGARTEN ASSESSMENT WITH THE PURPOSE OF MEASURING SCHOOL READINESS IF:

(1) THE ASSESSMENT IS COMPLETED ON OR BEFORE OCTOBER 1 AFTER THE FIRST FULL DAY OF KINDERGARTEN; AND

(2) THE AGGREGATE RESULTS ARE RETURNED WITHIN 45 DAYS.";

"(2) <u>A STANDARDIZED TEST MAY BE ADMINISTERED TO AN</u> ENROLLED PREKINDERGARTEN STUDENT BY A SCHOOL PSYCHOLOGIST OR OTHER SCHOOL-BASED PROFESSIONAL WHO INTENDS TO USE THE RESULTS IN ORDER TO IDENTIFY A DISABILITY.";
