BY repealing and reenacting, with amendments, Article – Local Government Section 13–129(a) and (b) Annotated Code of Maryland (2013 Volume and 2016 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Local Government 13-129.(1) In St. Mary's County, on or before June 30 of each year, a person owning (a) or keeping a dog shall apply to the [county tax collector] ANIMAL CONTROL DIVISION OF THE DEPARTMENT OF EMERGENCY SERVICES AND TECHNOLOGY for a license for the dog if the dog is at least 6 months old.
