2 **Washington Metropolitan Area Transit Authority – Washington Metrorail Safety**  
3 **Commission – Establishment and Compact**

4 FOR the purpose of establishing the Washington Metrorail Safety Commission;  
5 establishing the Metrorail Safety Commission Interstate Compact; granting the  
6 Commission safety, regulatory, and enforcement authority over the Washington  
7 Metropolitan Area Transit Authority Rail System and the power to act as the State  
8 safety oversight authority for WMATA; specifying the membership, powers,  
9 organization, and duties of the Commission; making the Compact contingent on the  
10 adoption of the Compact by certain other jurisdictions; making this Act an  
11 emergency measure; and generally relating to the Metrorail Safety Commission  
12 Interstate Compact.

~~2. THE SIGNATORIES TO THE WMATA COMPACT HEREBY ADOPT THIS MSC COMPACT PURSUANT TO 49 U.S.C. 5329. THE COMMISSION CREATED UNDER THIS SECTION SHALL HAVE SAFETY, REGULATORY, AND ENFORCEMENT AUTHORITY OVER THE WMATA RAIL SYSTEM AND SHALL ACT AS THE STATE SAFETY OVERSIGHT AUTHORITY FOR WMATA. 31 (D) IMPLEMENT AND ENFORCE RELEVANT FEDERAL AND STATE LAWS  
32 AND REGULATIONS RELATING TO SAFETY OF THE WMATA RAIL SYSTEM; AND

1           **(E) AUDIT EVERY 3 YEARS THE COMPLIANCE OF WMATA WITH**

3 **AN AUDIT ON AN ONGOING BASIS OVER A 3-YEAR TIME FRAME.**

4           **31. IN PERFORMING ITS DUTIES, THE COMMISSION, THROUGH ITS BOARD**  
5 **OR DESIGNATED EMPLOYEES OR AGENTS, MAY:**

6           **(A) CONDUCT, OR CAUSE TO BE CONDUCTED, INSPECTIONS,**  
7 **INVESTIGATIONS, EXAMINATIONS, AND TESTING OF WMATA PERSONNEL AND**  
8 **CONTRACTORS, PROPERTY, EQUIPMENT, FACILITIES, ROLLING STOCK, AND**

30                   **(3) DIRECTING WMATA TO PRIORITIZE SPENDING ON**

32                   **(4) REMOVING A SPECIFIC VEHICLE, INFRASTRUCTURE**  
33 **ELEMENT, OR HAZARD FROM THE WMATA RAIL SYSTEM; AND**



1           **(5) COMPELLING WMATA TO RESTRICT, SUSPEND, OR**  
2 **PROHIBIT RAIL SERVICE ON ALL OR PART OF THE WMATA RAIL SYSTEM WITH AN**

23 **RESPECTING THE EXERCISE OF THE POWERS CONFERRED BY THIS MSC COMPACT;**

24           **(C) CREATE AND ABOLISH OFFICES, EMPLOYMENTS, AND POSITIONS**  
25 **(OTHER THAN THOSE SPECIFICALLY PROVIDED FOR IN THIS MSC COMPACT)**  
26 **NECESSARY OR DESIRABLE FOR THE PURPOSES OF THE COMMISSION;**

27           **(D) DETERMINE A STAFFING LEVEL FOR THE COMMISSION THAT IS**  
28 **COMMENSURATE WITH THE SIZE AND COMPLEXITY OF THE WMATA RAIL SYSTEM,**  
29 **AND REQUIRE THAT EMPLOYEES AND OTHER DESIGNATED PERSONNEL OF THE**  
30 **COMMISSION, WHO ARE RESPONSIBLE FOR SAFETY OVERSIGHT, BE QUALIFIED TO**  
31 **PERFORM SUCH FUNCTIONS THROUGH APPROPRIATE TRAINING, INCLUDING,**  
32 **WITHOUT LIMITATION, SUCCESSFUL COMPLETION OF THE PUBLIC**  
33 **TRANSPORTATION SAFETY CERTIFICATION TRAINING PROGRAM;**

1 (E) CONTRACT FOR OR EMPLOY CONSULTING ATTORNEYS,  
2 INSPECTORS, ENGINEERS, AND SUCH OTHER EXPERTS NECESSARY OR DESIRABLE  
3 AND, WITHIN THE LIMITATIONS PRESCRIBED IN THIS MSC COMPACT, PRESCRIBE  
4 THEIR POWERS AND DUTIES AND FIX THEIR COMPENSATION;

5 (F) ENTER INTO AND PERFORM CONTRACTS, LEASES, AND  
6 AGREEMENTS NECESSARY OR DESIRABLE IN THE PERFORMANCE OF ITS DUTIES AND  
7 IN THE EXECUTION OF THE POWERS GRANTED UNDER THIS MSC COMPACT;

8 (G) APPLY FOR, RECEIVE, AND ACCEPT SUCH PAYMENTS,  
9 APPROPRIATIONS, GRANTS, GIFTS, LOANS, ADVANCES, AND OTHER FUNDS,  
10 PROPERTIES, AND SERVICES AS MAY BE TRANSFERRED OR MADE AVAILABLE TO IT  
11 BY THE UNITED STATES GOVERNMENT OR ANY OTHER PUBLIC OR PRIVATE ENTITY  
12 OR INDIVIDUAL, SUBJECT TO THE LIMITATIONS SPECIFIED IN SECTION 42;

13 (H) ADOPT AN OFFICIAL SEAL AND ALTER THE SAME AT ITS  
14 PLEASURE;

15 (I) ADOPT AND AMEND BY-LAWS, POLICIES, AND PROCEDURES  
16 GOVERNING THE REGULATION OF ITS AFFAIRS;

17 (J) APPOINT ONE OR MORE ADVISORY COMMITTEES; AND

18 (K) DO SUCH OTHER ACTS NECESSARY OR DESIRABLE FOR THE  
19 PERFORMANCE OF ITS DUTIES AND THE EXECUTION OF ITS POWERS UNDER THIS  
20 MSC COMPACT.

21 34. CONSISTENT WITH THIS MSC COMPACT, THE COMMISSION SHALL  
22 PROMULGATE RULES AND REGULATIONS TO CARRY OUT THE PURPOSES OF THIS  
23 MSC COMPACT.

24 ARTICLE V.

25 GENERAL PROVISIONS

26 A. ANNUAL SAFETY REPORT.

27 35. THE COMMISSION SHALL MAKE AND PUBLISH ANNUALLY A STATUS  
28 REPORT ON THE SAFETY OF THE WMATA RAIL SYSTEM, WHICH SHALL INCLUDE,  
29 AMONG OTHER REQUIREMENTS ESTABLISHED BY THE COMMISSION AND FEDERAL  
30 LAW, STATUS UPDATES OF OUTSTANDING CORRECTIVE ACTION PLANS,  
31 COMMISSION DIRECTIVES, AND ONGOING INVESTIGATIONS. A COPY OF EACH SUCH  
32 REPORT SHALL BE PROVIDED TO:

1           **(A) THE ADMINISTRATOR OF THE FEDERAL TRANSIT**  
2 **ADMINISTRATION;**

3           **(B) THE GOVERNOR OF VIRGINIA, THE GOVERNOR OF MARYLAND,**  
4 **AND THE MAYOR OF THE DISTRICT OF COLUMBIA;**

5           **(C) THE CHAIR OF THE COUNCIL OF THE DISTRICT OF COLUMBIA;**

6           **(D) THE PRESIDENT OF THE MARYLAND SENATE AND THE SPEAKER**  
7 **OF THE MARYLAND HOUSE OF DELEGATES;**

8           **(E) THE PRESIDENT OF THE VIRGINIA SENATE AND THE SPEAKER OF**  
9 **THE VIRGINIA HOUSE OF DELEGATES; AND**

10           **(F) THE GENERAL MANAGER AND EACH MEMBER OF THE BOARD OF**  
11 **DIRECTORS OF WMATA.**

12           **36. THE COMMISSION MAY PREPARE, PUBLISH, AND DISTRIBUTE SUCH**  
13 **OTHER SAFETY REPORTS THAT IT DEEMS NECESSARY OR DESIRABLE.**

14 **B. ANNUAL REPORT OF OPERATIONS.**

15           **37. THE COMMISSION SHALL MAKE AND PUBLISH AN ANNUAL REPORT ON**  
16 **ITS PROGRAMS, OPERATIONS, AND FINANCES, WHICH SHALL BE DISTRIBUTED IN**  
17 **THE SAME MANNER PROVIDED BY SECTION 35.**

18           **38. THE COMMISSION MAY ALSO PREPARE, PUBLISH, AND DISTRIBUTE**  
19 **SUCH OTHER PUBLIC REPORTS AND INFORMATIONAL MATERIALS AS IT DEEMS**  
20 **NECESSARY OR DESIRABLE.**

21 **C. ANNUAL INDEPENDENT AUDIT.**

22           **39. AN INDEPENDENT ANNUAL AUDIT SHALL BE MADE OF THE FINANCIAL**  
23 **ACCOUNTS OF THE COMMISSION. THE AUDIT SHALL BE MADE BY QUALIFIED**  
24 **CERTIFIED PUBLIC ACCOUNTANTS SELECTED BY THE BOARD, WHO SHALL HAVE NO**  
25 **PERSONAL INTEREST, DIRECT OR INDIRECT, IN THE FINANCIAL AFFAIRS OF THE**  
26 **COMMISSION OR ANY OF ITS OFFICERS OR EMPLOYEES. THE REPORT OF AUDIT**  
27 **SHALL BE PREPARED IN ACCORDANCE WITH GENERALLY ACCEPTED AUDITING**  
28 **PRINCIPLES AND SHALL BE DISTRIBUTED IN THE SAME MANNER PROVIDED BY**  
29 **SECTION 35. MEMBERS, EMPLOYEES, AGENTS, AND CONTRACTORS OF THE**  
30 **COMMISSION SHALL PROVIDE ACCESS TO INFORMATION NECESSARY OR DESIRABLE**  
31 **FOR THE CONDUCT OF THE ANNUAL AUDIT.**

32 **D. FINANCING.**

1       **40. THE COMMISSION'S OPERATIONS SHALL BE FUNDED, INDEPENDENTLY**  
2 **OF WMATA, BY THE SIGNATORY JURISDICTIONS AND, WHEN AVAILABLE, BY**  
3 **FEDERAL FUNDS. THE COMMISSION SHALL HAVE NO AUTHORITY TO LEVY TAXES.**

4       **41. THE SIGNATORIES SHALL UNANIMOUSLY AGREE ON ADEQUATE**  
5 **FUNDING LEVELS FOR THE COMMISSION AND MAKE EQUAL CONTRIBUTIONS OF**  
6 **SUCH FUNDING, SUBJECT TO ANNUAL APPROPRIATION, TO COVER THE PORTION OF**  
7 **COMMISSION OPERATIONS NOT FUNDED BY FEDERAL FUNDS.**

8       **42. THE COMMISSION MAY BORROW UP TO 5% OF ITS LAST ANNUAL**  
9 **APPROPRIATIONS BUDGET IN ANTICIPATION OF RECEIPTS, OR AS OTHERWISE SET**  
10 **FORTH IN THE APPROPRIATIONS BUDGET APPROVED BY ALL OF THE SIGNATORIES,**  
11 **FROM ANY LAWFUL LENDING INSTITUTION FOR ANY PURPOSE OF THIS MSC**  
12 **COMPACT, INCLUDING, WITHOUT LIMITATION, FOR ADMINISTRATIVE EXPENSES.**  
13 **SUCH LOANS SHALL BE FOR A TERM NOT TO EXCEED 2 YEARS, OR AT SUCH LONGER**  
14 **TERM APPROVED BY EACH SIGNATORY PURSUANT TO ITS LAWS AS EVIDENCED BY**  
15 **THE WRITTEN AUTHORIZATION BY THE MAYOR OF THE DISTRICT OF COLUMBIA AND**  
16 **THE GOVERNORS OF MARYLAND AND VIRGINIA, AND AT SUCH RATES OF INTEREST**  
17 **AS SHALL BE ACCEPTABLE TO THE COMMISSION.**

18       **43. WITH RESPECT TO THE DISTRICT OF COLUMBIA, THE COMMITMENT OR**  
19 **OBLIGATION TO RENDER FINANCIAL ASSISTANCE TO THE COMMISSION SHALL BE**  
20 **CREATED, BY APPROPRIATION OR IN SUCH OTHER MANNER, OR BY SUCH OTHER**  
21 **LEGISLATION, AS THE DISTRICT OF COLUMBIA SHALL DETERMINE; PROVIDED,**  
22 **THAT ANY SUCH COMMITMENT OR OBLIGATION SHALL BE APPROVED BY CONGRESS**  
23 **PURSUANT TO THE DISTRICT OF COLUMBIA HOME RULE ACT, APPROVED**  
24 **DECEMBER 24, 1973 (87 STAT. 774; D.C. OFFICIAL CODE § 1-201.01 ET SEQ.).**

25       **44. PURSUANT TO THE REQUIREMENTS OF 31 U.S.C. §§ 1341, 1342, 1349**  
26 **TO 1351, AND 1511 TO 1519, AND D.C. OFFICIAL CODE §§ 47-105 AND 47-355.01 TO**  
27 **355.08 (COLLECTIVELY, THE "ANTI-DEFICIENCY ACTS"), THE DISTRICT CANNOT**  
28 **OBLIGATE ITSELF TO ANY FINANCIAL COMMITMENT IN ANY PRESENT OR FUTURE**  
29 **YEAR UNLESS THE NECESSARY FUNDS TO PAY THAT COMMITMENT HAVE BEEN**  
30 **APPROPRIATED AND ARE LAWFULLY AVAILABLE FOR THE PURPOSE COMMITTED.**  
31 **THUS, PURSUANT TO THE ANTI-DEFICIENCY ACTS, NOTHING IN THE MSC**  
32 **COMPACT CREATES AN OBLIGATION OF THE DISTRICT IN ANTICIPATION OF AN**  
33 **APPROPRIATION FOR SUCH PURPOSE, AND THE DISTRICT'S LEGAL LIABILITY FOR**  
34 **THE PAYMENT OF ANY AMOUNT UNDER THIS MSC COMPACT DOES NOT AND MAY**  
35 **NOT ARISE OR OBTAIN IN ADVANCE OF THE LAWFUL AVAILABILITY OF**  
36 **APPROPRIATED FUNDS FOR THE APPLICABLE FISCAL YEAR.**

37 **E. TAX EXEMPTION.**

1       **45. THE EXERCISE OF THE POWERS GRANTED BY THIS MSC COMPACT**  
2 **SHALL IN ALL RESPECTS BE FOR THE BENEFIT OF THE PEOPLE OF THE DISTRICT OF**  
3 **COLUMBIA, THE COMMONWEALTH OF VIRGINIA, AND THE STATE OF MARYLAND**  
4 **AND FOR THE INCREASE OF THEIR SAFETY, COMMERCE, AND PROSPERITY, AND AS**  
5 **THE ACTIVITIES ASSOCIATED WITH THIS MSC COMPACT SHALL CONSTITUTE THE**  
6 **PERFORMANCE OF ESSENTIAL GOVERNMENTAL FUNCTIONS, THE COMMISSION**  
7 **SHALL NOT BE REQUIRED TO PAY ANY TAXES OR ASSESSMENTS UPON THE SERVICES**  
8 **OR ANY PROPERTY ACQUIRED OR USED BY THE COMMISSION UNDER THE**  
9 **PROVISIONS OF THIS MSC COMPACT OR UPON THE INCOME THEREFROM, AND**  
10 **SHALL AT ALL TIMES BE FREE FROM TAXATION WITHIN THE DISTRICT OF**  
11 **COLUMBIA, THE COMMONWEALTH OF VIRGINIA, AND THE STATE OF MARYLAND.**

12 **F. RECONSIDERATION OF COMMISSION ORDERS.**

13       **46. WMATA SHALL HAVE THE RIGHT TO PETITION THE COMMISSION FOR**  
14 **RECONSIDERATION OF AN ORDER BASED ON RULES AND PROCEDURES DEVELOPED**  
15 **BY THE COMMISSION.**

16       **47. CONSISTENT WITH SECTION 16, THE FILING OF A PETITION FOR**  
17 **RECONSIDERATION SHALL NOT ACT AS A STAY UPON THE EXECUTION OF A**  
18 **COMMISSION ORDER, OR ANY PART OF IT, UNLESS THE COMMISSION ORDERS**  
19 **OTHERWISE. WMATA MAY APPEAL ANY ADVERSE ACTION ON A PETITION FOR**  
20 **RECONSIDERATION AS SET FORTH IN SECTION 48.**

21 **G. JUDICIAL MATTERS.**

22       **48. THE UNITED STATES DISTRICT COURT FOR THE EASTERN DISTRICT OF**  
23 **VIRGINIA, ALEXANDRIA DIVISION, THE UNITED STATES DISTRICT COURT FOR THE**  
24 **DISTRICT OF MARYLAND, SOUTHERN DIVISION, AND THE UNITED STATES**  
25 **DISTRICT COURT FOR THE DISTRICT OF COLUMBIA SHALL HAVE EXCLUSIVE AND**  
26 **ORIGINAL JURISDICTION OF ALL ACTIONS BROUGHT BY OR AGAINST THE**  
27 **COMMISSION AND TO ENFORCE SUBPOENAS UNDER THIS MSC COMPACT.**

28       **49. THE COMMENCEMENT OF A JUDICIAL PROCEEDING SHALL NOT**  
29 **OPERATE AS A STAY OF A COMMISSION ORDER UNLESS SPECIFICALLY ORDERED BY**  
30 **THE COURT.**

31 **H. LIABILITY AND INDEMNIFICATION.**

32       **50. THE COMMISSION AND ITS MEMBERS, ALTERNATE MEMBERS,**  
33 **OFFICERS, AGENTS, EMPLOYEES, OR REPRESENTATIVES SHALL NOT BE LIABLE FOR**  
34 **SUIT OR ACTION OR FOR ANY JUDGMENT OR DECREE FOR DAMAGES, LOSS, OR**  
35 **INJURY RESULTING FROM ACTION TAKEN WITHIN THE SCOPE OF THEIR**  
36 **EMPLOYMENT OR DUTIES UNDER THIS MSC COMPACT, NOR REQUIRED IN ANY CASE**

1 ARISING OR ANY APPEAL TAKEN UNDER THIS MSC COMPACT TO GIVE A  
2 SUPERSEDEAS BOND OR SECURITY FOR DAMAGES. NOTHING IN THIS SECTION  
3 SHALL BE CONSTRUED TO PROTECT SUCH PERSON FROM SUIT OR LIABILITY FOR  
4 DAMAGE, LOSS, INJURY, OR LIABILITY CAUSED BY THE INTENTIONAL OR WILLFUL  
5 AND WANTON MISCONDUCT OF SUCH PERSON.

6 **51.** THE COMMISSION SHALL BE LIABLE FOR ITS CONTRACTS AND FOR ITS  
7 TORTS AND THOSE OF ITS MEMBERS, ALTERNATE MEMBERS, OFFICERS, AGENTS,  
8 EMPLOYEES, AND REPRESENTATIVES COMMITTED IN THE CONDUCT OF ANY  
9 PROPRIETARY FUNCTION, IN ACCORDANCE WITH THE LAW OF THE APPLICABLE  
10 SIGNATORY (INCLUDING, WITHOUT LIMITATION, RULES ON CONFLICT OF LAWS) BUT  
11 SHALL NOT BE LIABLE FOR ANY TORTS OCCURRING IN THE PERFORMANCE OF A  
12 GOVERNMENTAL FUNCTION. THE EXCLUSIVE REMEDY FOR SUCH BREACH OF  
13 CONTRACT OR TORT FOR WHICH THE COMMISSION SHALL BE LIABLE, AS HEREIN  
14 PROVIDED, SHALL BE BY SUIT AGAINST THE COMMISSION. NOTHING CONTAINED IN  
15 THIS MSC COMPACT SHALL BE CONSTRUED AS A WAIVER BY THE DISTRICT OF  
16 COLUMBIA, THE COMMONWEALTH OF VIRGINIA, OR THE STATE OF MARYLAND OF  
17 ANY IMMUNITY FROM SUIT.

18 **I.** COMMITMENT OF PARTIES.

19 **52.** EACH OF THE SIGNATORIES PLEDGES TO EACH OTHER FAITHFUL  
20 COOPERATION IN PROVIDING SAFETY OVERSIGHT FOR THE WMATA RAIL SYSTEM,  
21 AND, TO AFFECT SUCH PURPOSES, AGREES TO CONSIDER IN GOOD FAITH AND  
22 REQUEST ANY NECESSARY LEGISLATION TO ACHIEVE THE OBJECTIVES OF THIS  
23 MSC COMPACT.

24 **J.** AMENDMENTS AND SUPPLEMENTS.

25 **53.** AMENDMENTS AND SUPPLEMENTS TO THIS MSC COMPACT SHALL BE  
26 ADOPTED BY LEGISLATIVE ACTION OF EACH OF THE SIGNATORIES AND THE  
27 CONSENT OF CONGRESS. WHEN ONE SIGNATORY ADOPTS AN AMENDMENT OR  
28 SUPPLEMENT TO AN EXISTING SECTION OF THIS MSC COMPACT, THAT AMENDMENT  
29 OR SUPPLEMENT SHALL NOT BE IMMEDIATELY EFFECTIVE, AND THE PREVIOUSLY  
30 ENACTED PROVISION OR PROVISIONS SHALL REMAIN IN EFFECT IN EACH  
31 JURISDICTION UNTIL THE AMENDMENT OR SUPPLEMENT IS APPROVED BY THE  
32 OTHER SIGNATORIES AND IS CONSENTED TO BY CONGRESS.

33 **K.** WITHDRAWAL AND TERMINATION.

34 **54.** ANY SIGNATORY MAY WITHDRAW FROM THIS MSC COMPACT, WHICH  
35 ACTION SHALL CONSTITUTE A TERMINATION OF THIS MSC COMPACT.

1       **55. WITHDRAWAL FROM THIS MSC COMPACT SHALL BE BY A SIGNATORY'S**  
2 **REPEAL OF THIS MSC COMPACT FROM ITS LAWS, BUT SUCH REPEAL SHALL NOT**  
3 **TAKE EFFECT UNTIL 2 YEARS AFTER THE EFFECTIVE DATE OF THE REPEALED**  
4 **STATUTE AND WRITTEN NOTICE OF THE WITHDRAWAL BEING GIVEN BY THE**  
5 **WITHDRAWING SIGNATORY TO THE GOVERNORS OR MAYOR, AS APPROPRIATE, OF**  
6 **THE OTHER SIGNATORIES.**

7       **56. PRIOR TO TERMINATION OF THIS MSC COMPACT, THE COMMISSION**  
8 **SHALL PROVIDE TO EACH SIGNATORY:**

9           **(A) A MECHANISM FOR CONCLUDING THE OPERATIONS OF THE**  
10 **COMMISSION;**

11           **(B) A PROPOSAL TO MAINTAIN STATE SAFETY OVERSIGHT OF THE**  
12 **WMATA RAIL SYSTEM IN COMPLIANCE WITH APPLICABLE FEDERAL LAW;**

13           **(C) A PLAN TO HOLD SURPLUS FUNDS IN A TRUST FOR A SUCCESSOR**  
14 **REGULATORY ENTITY FOR 4 YEARS AFTER THE TERMINATION OF THIS MSC**  
15 **COMPACT; AND**

16           **(D) A PLAN TO RETURN ANY SURPLUS FUNDS THAT REMAIN 4 YEARS**  
17 **AFTER THE CREATION OF THE TRUST.**

18 **L. CONSTRUCTION AND SEVERABILITY.**

19       **57. THIS MSC COMPACT SHALL BE LIBERALLY CONSTRUED TO**  
20 **EFFECTUATE THE PURPOSES FOR WHICH IT IS CREATED.**

21       **58. IF ANY PART OR PROVISION OF THIS MSC COMPACT OR THE**  
22 **APPLICATION THEREOF TO ANY PERSON OR CIRCUMSTANCES BE ADJUDGED**  
23 **INVALID BY ANY COURT OF COMPETENT JURISDICTION, SUCH JUDGMENT SHALL BE**  
24 **CONFINED IN ITS OPERATION TO THE PART, PROVISION, OR APPLICATION DIRECTLY**  
25 **INVOLVED IN THE CONTROVERSY IN WHICH SUCH JUDGMENT SHALL HAVE BEEN**  
26 **RENDERED AND SHALL NOT AFFECT OR IMPAIR THE VALIDITY OF THE REMAINDER**  
27 **OF THIS MSC COMPACT OR THE APPLICATION THEREOF TO OTHER PERSONS OR**  
28 **CIRCUMSTANCES, AND THE SIGNATORIES HEREBY DECLARE THAT THEY WOULD**  
29 **HAVE ENTERED INTO THIS MSC COMPACT OR THE REMAINDER THEREOF HAD THE**  
30 **INVALIDITY OF SUCH PROVISION OR APPLICATION THEREOF BEEN APPARENT.**

31 **M. ADOPTION; EFFECTIVE DATE.**

32       **59. THIS MSC COMPACT SHALL BE ADOPTED BY THE SIGNATORIES IN THE**  
33 **MANNER PROVIDED BY LAW THEREFOR AND SHALL BE SIGNED AND SEALED IN 4**  
34 **DUPLICATE ORIGINAL COPIES. ONE SUCH COPY SHALL BE FILED WITH THE**

1 SECRETARY OF STATE OF THE STATE OF MARYLAND, THE SECRETARY OF THE  
2 COMMONWEALTH OF VIRGINIA, AND THE SECRETARY OF THE DISTRICT OF  
3 COLUMBIA IN ACCORDANCE WITH THE LAWS OF EACH JURISDICTION. ONE COPY  
4 SHALL BE FILED AND RETAINED IN THE ARCHIVES OF THE COMMISSION UPON ITS  
5 ORGANIZATION. THIS MSC COMPACT SHALL BECOME EFFECTIVE UPON THE  
6 ENACTMENT OF CONCURRING LEGISLATION BY THE DISTRICT OF COLUMBIA, THE  
7 COMMONWEALTH OF VIRGINIA, AND THE STATE OF MARYLAND, AND CONSENT  
8 THERE TO BY CONGRESS AND WHEN ALL OTHER ACTS OR ACTIONS HAVE BEEN  
9 TAKEN, INCLUDING, WITHOUT LIMITATION, THE SIGNING AND EXECUTION OF THIS  
10 MSC COMPACT BY THE GOVERNORS OF MARYLAND AND VIRGINIA AND THE MAYOR  
11 OF THE DISTRICT OF COLUMBIA.

12 N. CONFLICT OF LAWS.

13 60. ANY CONFLICT BETWEEN ANY AUTHORITY GRANTED HEREIN, OR THE  
14 EXERCISE OF SUCH AUTHORITY, AND THE PROVISIONS OF THE WMATA COMPACT  
15 SHALL BE RESOLVED IN FAVOR OF THE EXERCISE OF SUCH AUTHORITY BY THE  
16 COMMISSION.

17 61. ALL OTHER GENERAL OR SPECIAL LAWS INCONSISTENT WITH THIS MSC  
18 COMPACT ARE HEREBY DECLARED TO BE INAPPLICABLE TO THE COMMISSION OR  
19 ITS ACTIVITIES.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act may not take effect  
21 until a similar Act is enacted by the Commonwealth of Virginia and by the District of  
22 Columbia; that the Commonwealth of Virginia and the District of Columbia each is  
23 requested to concur in this Act of the General Assembly of Maryland by the enactment of a  
24 similar Act; that the Department of Legislative Services shall notify the appropriate  
25 officials of the Commonwealth of Virginia, the District of Columbia, and the United States  
26 Congress of the enactment of this Act; and that upon the concurrence in this Act by the  
27 Commonwealth of Virginia and by the District of Columbia and approval by the United  
28 States Congress, the Governor of the State of Maryland shall issue a proclamation declaring  
29 this Act valid and effective and shall forward a copy of the proclamation to the Director of  
30 the Department of Legislative Services.

31 SECTION 3. AND BE IT FURTHER ENACTED, That, subject to Section 2 of this  
32 Act, this Act ~~shall take effect June 1, 2017~~ is an emergency measure, is necessary for the  
33 immediate preservation of the public health or safety, has been passed by a ye and nay  
34 vote supported by three-fifths of all the members elected to each of the two Houses of the  
35 General Assembly, and shall take effect from the date it is enacted.
