# SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

7 (a) The State Disabilities Plan shall provide for the coordination of support 8 services that:

9 (1) ensure compliance with the federal Americans with Disabilities Act and 10 other relevant federal and State provisions intended to protect the civil rights of individuals 11 with disabilities;

12 (2) are necessary for individuals with disabilities to achieve maximum 13 participation in the mainstream of the community in the most integrated setting possible; 14 and

(3) address, on a statewide basis, the improvement of:

16 (i) the capacity of communities to support individuals with 17 disabilities with personal attendant care and other long-term care options that are 18 self-directed;

19 (ii) the availability of accessible, integrated, and affordable housing 20 options;

21 (iii) reliable transportation options;

(iv) employment and training options, including self-employment
 and noncongregant competitive opportunities available in an integrated environment in
 which there are individuals with and without disabilities;

- (v) somatic and [mental] **BEHAVIORAL** health options;

(vii) support services for children, youth, and their families to enablethem to achieve successful learning; [and]

29 (viii) family support services, including respite care; AND

1 (IX) CRIME CONTROL, PUBLIC SAFETY, AND CORRECTIONAL 2 SERVICES THAT APPROPRIATELY TAKE INTO ACCOUNT THE NEEDS AND RIGHTS OF 3 INDIVIDUALS WITH DISABILITIES.

4 (b) The State Disabilities Plan shall assess the provision of and resources for 5 support services for individuals with disabilities.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 7 October 1, 2017.
