1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Sunday Hours of Sale**

3 FOR the purpose of altering the starting time on Sunday for the sale of alcoholic beverages
4 for certain license holders in Frederick County for certain purposes; and generally
5 relating to the sale of alcoholic beverages in Frederick County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Alcoholic Beverages**

19 20–102.

3 (a) (1) A holder of a Class A beer license may sell beer:

4 (i) on Monday through Saturday, from 6 a.m. to 2 a.m. the following
5 day; and

6 (ii) on Sunday, from **[11] 10** a.m. to 2 a.m. the following day.

7 (2) (i) The Board may grant a special Sunday opening permit to the
8 license holder.

9 (ii) The permit authorizes the holder to sell beer for off–premises
10 consumption on Sunday from **[11] 10** a.m. to 2 a.m. the following day.

11 (iii) The annual permit fee is \$100 in addition to the annual fee for
12 the license.

13 (iv) The permit is not considered a separate class of license and, if it
14 is granted, the privilege shall be incorporated into the license.

15 (b) (1) A holder of a Class B beer license may sell beer:

16 (i) on Monday through Saturday, for on– and off–premises
17 consumption, from 6 a.m. to 2 a.m. the following day; and

18 (ii) on Sunday:

19 1. subject to paragraph (2) of this subsection, for
20 on–premises consumption:

21 A. from **[11] 10** a.m. to 2 a.m. the following day; or

22 B. for a specific event that the Board has approved, the hours
23 for the event that are set by the Board.

24 2. for off–premises consumption, from 1 p.m. to 2 a.m. the
25 following day.

26 (2) The license holder may not sell beer at a bar or counter on Sunday.

27 (c) (1) A holder of a Class C beer (on–sale) license may sell beer:

28 (i) on Monday through Saturday, from 6 a.m. to 2 a.m. the following
29 day; and

1 (ii) subject to paragraph (2) of this subsection, on Sunday:

2 1. from [11] 10 a.m. to 2 a.m. the following day; or

3 2. for a specific event that the Board has approved, the hours
4 for the event that are set by the Board.

5 (2) The license holder may not sell beer at a bar or counter on Sunday.

6 (d) Reserved.

7 20–2004.

8 (a) (1) A holder of a Class A beer and wine license may sell beer and wine:

9 (i) on Monday through Saturday, from 6 a.m. to 2 a.m. the following
10 day; and

11 (ii) on Sunday, from [11] 10 a.m. to 2 a.m. the following day.

12 (2) (i) The Board may grant a special Sunday opening permit to the
13 license holder.

14 (ii) The permit authorizes the holder to sell beer for off–premises
15 consumption on Sunday from [11] 10 a.m. to 2 a.m. the following day.

16 (iii) The annual permit fee is \$140 in addition to the annual fee for
17 the license.

18 (iv) The permit is not considered a separate class of license and, if it
19 is granted, the privilege shall be incorporated into the license.

20 (b) (1) A holder of a Class B beer and wine license may sell beer and wine:

21 (i) on Monday through Saturday, for on– and off–premises
22 consumption, from 6 a.m. to 2 a.m. the following day; and

23 (ii) on Sunday:

24 1. subject to paragraph (2) of this subsection, for
25 on–premises consumption:

26 A. from [11] 10 a.m. to 2 a.m. the following day; or

27 B. for a specific event that the Board has approved, the hours
28 for the event that are set by the Board; and

1 (ii) on Sunday:

2 1. subject to paragraph (2) of this subsection, for
3 on-premises consumption:

4 A. from [11] 10 a.m. to 2 a.m. the following day; or

5 B. for a specific event that the Board has approved, the hours
6 for the event that are set by the Board; and

7 2. for off-premises consumption, from 1 p.m. to 2 a.m. the
8 following day.

9 (2) The license holder may not sell beer, wine, or liquor at a bar or counter
10 on Sunday.

11 (c) A holder of a Class B beer, wine, and liquor license in the Ballenger (23rd)
12 election district may sell beer, wine, and liquor:

13 (1) on Monday through Saturday, from 6 a.m. to 2 a.m. the following day;
14 and

15 (2) on Sunday, from [11] 10 a.m. to 2 a.m. the following day.

16 (d) (1) A holder of a Class C beer, wine, and liquor license may sell beer, wine,
17 and liquor for on- and off-premises consumption:

18 (i) on Monday through Saturday, from 6 a.m. to 2 a.m. the following
19 day; and

20 (ii) subject to paragraph (2) of this subsection, on Sunday:

21 1. from [11] 10 a.m. to 2 a.m. the following day; or

22 2. for a specific event that the Board has approved, the hours
23 for the event that are set by the Board.

24 (2) The license holder may not sell beer, wine, or liquor at a bar or counter
25 on Sunday.

26 (e) Reserved.

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
28 1, 2017.
