## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Employees' and Teachers' Pension Systems – Reformed Contributory Pension**  
3 **Benefit – Service Credit Purchase Clarification**

4 FOR the purpose of clarifying that a member of the Employees' Pension System or the  
5 Teachers' Pension System who is subject to the Reformed Contributory Pension  
6 Benefit is eligible to purchase service credit for a certain period of employment under  
7 certain circumstances; and generally relating to the purchase of service credit for a  
8 member of the Employees' Pension System or the Teachers' Pension System who is  
9 subject to the Reformed Contributory Pension Benefit.

10 BY repealing and reenacting, with amendments,

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That the Laws of Maryland read as follows:

17 **Article – State Personnel and Pensions**

18 23–306.2.

19 (a) A member who is subject to the contributory pension benefit, [or] the  
20 Alternate Contributory Pension Selection, **OR THE REFORMED CONTRIBUTORY**

1 **PENSION BENEFIT** may purchase service credit as provided in subsection (b) of this  
2 section for periods of employment described in subsection (c) of this section for which the  
3 member is not otherwise entitled.

4 (b) (1) A member who purchases service credit under this section shall:

5 (i) complete a claim for the service credit and file it with the Board  
6 of Trustees on a form that the Board of Trustees provides; and

7 (ii) pay to the Board of Trustees in a single payment the member  
8 contributions the member would have made for the period of employment for which service  
9 credit is being purchased if the member had earned the prior service in the same part of  
10 the Employees' Pension System or Teachers' Pension System in which the member is  
11 currently enrolled, plus regular interest to the date of payment.

12 (2) A member may pay for service credit purchased under this section at  
13 any time before retirement.

14 (3) Subject to § 414(h)(2) of the Internal Revenue Code, an individual's  
15 accumulated contributions in excess of the amount determined under paragraph (1) of this  
16 subsection shall be refunded on request.

17 (c) (1) Except as provided in paragraph (2) of this subsection, a member may  
18 purchase service credit for a period of employment as a member of the Employees' Pension  
19 System or Teachers' Pension System if the member:

20 (i) has withdrawn the member's accumulated contributions after a  
21 prior termination of membership; and

22 (ii) was subject to the contributory pension benefit, [or] the  
23 Alternate Contributory Pension Selection, **OR THE REFORMED CONTRIBUTORY**  
24 **PENSION BENEFIT** when the member previously terminated membership in the  
25 Employees' Pension System or the Teachers' Pension System.

26 (2) A member may not purchase eligibility service credit that exceeds the  
27 member's creditable service credit.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
29 1, 2017.
