A BILL ENTITLED

1 AN ACT concerning

2 **Correctional Services – Commissioner’s Duties – Staffing Report**

3 FOR the purpose of requiring the Commissioner of Correction to submit a certain security
4 and staffing report to the Secretary of Public Safety, the Governor, and the General
5 Assembly at a certain time; requiring the report to be based on a certain survey;
6 requiring the report to include certain information; and generally relating to the
7 duties of the Commissioner of Correction.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Correctional Services**

16 **3–207.1.**

17 **(A) ON OR BEFORE OCTOBER 31, 2017, AND ON OR BEFORE OCTOBER 31 IN**
18 **EVERY ODD–NUMBERED YEAR THEREAFTER, THE COMMISSIONER SHALL SUBMIT A**
19 **SECURITY AND STAFFING REPORT COVERING THE PRIOR 2–YEAR PERIOD TO THE**
20 **SECRETARY, THE GOVERNOR, AND, IN ACCORDANCE WITH § 2–1246 OF THE STATE**
21 **GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY.**

1 **(B) THE REPORT SHALL BE BASED ON A JOINT SURVEY CONDUCTED BY THE**
2 **ADMINISTRATION OF THE DIVISION OF CORRECTION AND THE EXCLUSIVE**
3 **COLLECTIVE BARGAINING REPRESENTATIVE OF THE EMPLOYEES.**

4 **(C) THE REPORT SHALL INCLUDE:**

5 **(1) A POST-BY-POST ANALYSIS THAT IDENTIFIES THE ACTUAL**
6 **NUMBER OF POSITIONS NEEDED TO SAFELY AND SECURELY STAFF EACH**
7 **INSTITUTION;**

8 **(2) THE AMOUNT OF OVERTIME CURRENTLY BEING USED TO MEET**
9 **MINIMUM STANDARDS;**

10 **(3) AN ACCOUNTING OF ALL INSTITUTION ACTIVITIES THAT HAVE**
11 **BEEN IMPACTED BY STAFFING LEVELS;**

12 **(4) AN ASSESSMENT OF EXPECTED FUTURE TURNOVER IN**
13 **PERSONNEL; AND**

14 **(5) AN ANALYSIS OF THE NEED FOR ADDITIONAL STAFF.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 October 1, 2017.
