CHAPTER _____

1 AN ACT concerning

2 **Adult Protective Services – Investigation – Time Period Increase**

3 FOR the purpose of increasing the period of time during which a local department of social
4 services, or in Montgomery County the county department of health and human
5 services, must complete an investigation after receiving a report of suspected abuse,
6 neglect, self-neglect, or exploitation of an alleged vulnerable adult; and generally
7 relating to investigations conducted by local departments under adult protective
8 services programs.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

1 Article – Family Law

2 14–303.

3 (a) To protect the welfare of the alleged vulnerable adult the local department
4 shall begin a thorough investigation:5 (1) within 5 working days after the receipt of the report of suspected abuse,
6 neglect, self–neglect, or exploitation; or7 (2) within 24 hours after the receipt of the report of suspected abuse,
8 neglect, self–neglect, or exploitation if the report indicates that an emergency exists.

9 (b) The investigation shall include:

10 (1) a determination of whether:

11 (i) the individual is a vulnerable adult; and

12 (ii) there has been abuse, neglect, self–neglect, or exploitation; and

13 (2) if the individual is determined to be a vulnerable adult and to have
14 suffered abuse, neglect, self–neglect, or exploitation:15 (i) a determination of the nature, extent, and cause of the abuse,
16 neglect, self–neglect, or exploitation;17 (ii) a determination of the identity of the person or persons
18 responsible for the abuse, neglect, self–neglect, or exploitation;

19 (iii) an evaluation of the home environment; and

20 (iv) a determination of any other pertinent facts.

21 (d) An investigation under this section shall be completed within:

22 (1) ~~30~~ 60 days; or

23 (2) 10 days if the report indicates that an emergency exists.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
25 October 1, 2017.
