3 FOR the purpose of establishing a marketplace license in a certain alcoholic beverages district in Baltimore City; authorizing the Baltimore City Board of License 4 $\mathbf{5}$ Commissioners to issue the license: specifying the scope, hours for sale, and fees for 6 the license; authorizing a license holder to obtain a refillable container permit under 7 certain conditions; specifying certain capacity standards to be met by the marketplace; authorizing a holder of a Class B beer, wine, and liquor license to 8 9 surrender the license to the Board under certain circumstances; requiring the Board 10 to issue a substitute marketplace license under certain circumstances; defining a 11 certain term; and generally relating to alcoholic beverages licenses in Baltimore City.

AND BE IT FURTHER ENACTED, That: A license holder in Baltimore City who has a Class B beer, wine, and liquor 18(a) 19 license on or after July 1, 2016, and meets the requirements for a marketplace license under 20this Act may surrender the Class B beer, wine, and liquor license to the Baltimore City Board of License Commissioners. 21

(b) If a license holder surrenders a Class B beer, wine, and liquor license under
subsection (a) of this section, the Baltimore City Board of License Commissioners shall
issue a substitute marketplace license without additional payment or penalty to the license
holder.
