BY repealing and reenacting, with amendments, Article – Estates and Trusts Section 2–108(a) and (i) Annotated Code of Maryland (2011 Replacement Volume and 2016 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article - Estates and Trusts** 2-108.**(1)** Except in Montgomery County and Harford County, the judges of the courts shall receive compensation and allowances as prescribed by law.
