A BILL ENTITLED

1 AN ACT concerning

2 **Child Abuse – Sex Trafficking**
3 **(Protecting Victims of Sex Trafficking Act of 2017)**

4 FOR the purpose of altering the definition of “sexual abuse” in provisions of law relating to
5 child abuse to include the sex trafficking of a child; defining the terms “sexual
6 molestation or exploitation” and “sex trafficking” in provisions of law relating to child
7 abuse; making this Act an emergency measure; and generally relating to child abuse
8 and sex trafficking.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Family Law**

2 **(X) “SEX TRAFFICKING” MEANS THE RECRUITMENT, HARBORING,**
 3 **TRANSPORTATION, PROVISION, OBTAINING, PATRONIZING, OR SOLICITING OF A**
 4 **CHILD FOR THE PURPOSE OF A COMMERCIAL SEX ACT.**

5 **[(x) (1)] (Y) “Sexual abuse” means any act that involves [sexual molestation**
 6 **or exploitation of a child by]:**

7 **(1) SEXUAL MOLESTATION OR EXPLOITATION OF A CHILD BY** a parent
 8 or other person who has permanent or temporary care or custody or responsibility for
 9 supervision of a child, or by any household or family member; **OR**

10 **(2) SEX TRAFFICKING OF A CHILD.**

11 **[(2) (Z) [“Sexual abuse”] “SEXUAL MOLESTATION OR EXPLOITATION”**
 12 **includes:**

13 **[(i)] (1) allowing or encouraging a child to engage in:**

14 **[1.] (I) obscene photography, films, poses, or similar**
 15 **activity;**

16 **[2.] (II) pornographic photography, films, poses, or similar**
 17 **activity; or**

18 **[3.] (III) prostitution;**

19 **[(ii)] human trafficking;**

20 **(iii)] (2) incest;**

21 **[(iv)] (3) rape;**

22 **[(v)] (4) sexual offense in any degree;**

23 **[(vi)] (5) sodomy; and**

24 **[(vii)] (6) unnatural or perverted sexual practices.**

25 **[(y)] (AA) “Unsubstantiated” means a finding that there is an insufficient amount**
 26 **of evidence to support a finding of indicated or ruled out.**

27 **SECTION 2. AND BE IT FURTHER ENACTED,** That this Act is an emergency
 28 **measure, is necessary for the immediate preservation of the public health or safety, has**

1 been passed by a ye and nay vote supported by three-fifths of all the members elected to
2 each of the two Houses of the General Assembly, and shall take effect from the date it is
3 enacted.
