BY repealing and reenacting, without amendments, Article – Criminal Law Section 13-1301 and 13-1302 Annotated Code of Maryland (2012 Replacement Volume and 2016 Supplement) BY repealing and reenacting, with amendments, Article – Criminal Law Section 13-1304 Annotated Code of Maryland (2012 Replacement Volume and 2016 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Criminal Law 13-1301.
