- 4 (5) a crime committed in a federal, military, tribal, or other jurisdiction 5 that, if committed in this State, would constitute one of the crimes listed in items (1) 6 through (3) of this subsection; or
- 7 (6) a crime in a court of Canada, Great Britain, Australia, New Zealand, or 8 any other foreign country where the United States Department of State has determined in 9 its Country Reports on Human Rights Practices that an independent judiciary generally or 10 vigorously enforced the right to a fair trial during the year in which the conviction occurred 11 that, if the crime were committed in this State, would constitute one of the crimes listed in 12 items (1) through (3) of this subsection.



- (c) (1) A person who has been adjudicated delinquent for an act that, if committed by an adult, would constitute a violation of § 3–303[,] OR § 3–304[, § 3–305, or § 3–306] of the Criminal Law Article, § 3–305 OR § 3–306 OF THE CRIMINAL LAW ARTICLE AS THE SECTIONS EXISTED BEFORE OCTOBER 1, 2017, or § 3–307(a)(1) or (2) or § 3–308(b)(1) of the Criminal Law Article involving conduct described in § 3–301(e)(2) of the Criminal Law Article, shall register with the person's supervising authority if:
- 20 (i) the person was a minor who was at least 13 years old at the time 21 the delinquent act was committed;
- 22 (ii) the State's Attorney or the Department of Juvenile Services 23 requests that the person be required to register;
