BY repealing and reenacting, with amendments, Article – Real Property Section 11–104(e) and 11B–116 Annotated Code of Maryland (2015 Replacement Volume and 2016 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Real Property

- 1 (e) (1) A corrective amendment to the bylaws may be made in accordance with 2 § 11–103.1 of this title, or as provided in paragraph (2) of this subsection.
- 3 (2) (i) Except as provided in subparagraph (ii) of this paragraph, 4 [unless a higher percentage is required in the bylaws,] the bylaws may be amended by the 5 affirmative vote of unit owners [having at least 66 2/3 percent of the votes in the council of unit owners] AS PROVIDED UNDER PARAGRAPH (6) OF THIS SUBSECTION.
- 7 (ii) The bylaws may be amended by the affirmative vote of unit 8 owners having at least 51% of the votes in the council of unit owners for the purpose of 9 requiring all unit owners to maintain condominium unit owner insurance policies on their 10 units.
- 11 (3) (i) Except as provided in paragraph (4) of this subsection, if the declaration or bylaws contain a provision requiring any action on the part of the holder of a mortgage or deed of trust on a unit in order to amend the bylaws, that provision shall be deemed satisfied if the procedures under this paragraph are satisfied.
- 15 (ii) If the declaration or bylaws contain a provision described in 16 subparagraph (i) of this paragraph, the council of unit owners shall cause to be delivered to 17 each holder of a mortgage or deed of trust entitled to notice, a copy of the proposed 18 amendment to the bylaws.
- 19 (iii) If a holder of the mortgage or deed of trust that receives the 20 proposed amendment fails to object, in writing, to the proposed amendment within 60 days 21 from the date of actual receipt of the proposed amendment, the holder shall be deemed to 22 have consented to the adoption of the amendment.
- 23 (4) Paragraph (3) of this subsection does not apply to amendments that:
- 24 (i) Alter the priority of the lien of the mortgage or deed of trust;
- 25 (ii) Materially impair or affect the unit as collateral; or
- 26 (iii) Materially impair or affect the right of the holder of the mortgage 27 or deed of trust to exercise any rights under the mortgage, deed of trust, or applicable law.
 - (5) Each particular set forth in subsection (b) of this section shall be expressed in the bylaws as amended. An amendment under paragraph (2) of this subsection shall be entitled to be recorded if accompanied by a certificate of the person specified in the bylaws to count votes at the meeting of the council of unit owners that the amendment was approved by unit owners having the required percentage of the votes and shall be effective on recordation. This certificate shall be conclusive evidence of approval.

2	vote of lot owners IN GOOD STANDING having at least [two-thirds] 55% 60% of the votes
3	in the development, or by a lower percentage if required in the governing document.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 5 October 1, 2017.
