3 FOR the purpose of prohibiting a person from knowingly entering onto the land or into the 4 airspace above the land of another person without permission or otherwise 5 committing a trespass in order to capture a visual image, sound recording, or other 6 physical impression of the other person engaging in a certain activity in a certain 7 manner; prohibiting a person from violating this Act through the use of any device, 8 regardless of whether there is a physical trespass, in certain circumstances; 9 providing for a civil cause of action against a person for violating this Act; providing that a certain person is entitled to recover certain damages from a person violating 10 11 this Act; providing for additional damages if a violation of this Act was done for a 12 commercial purpose; authorizing a court to grant certain equitable relief in certain 13 circumstances; providing that this Act shall not be construed to impair or limit 14 certain otherwise lawful activities; defining certain terms; and generally relating to 15 invasion of privacy.
