1 AN ACT concerning

2 **Public Integrity Act of 2017**

3 FOR the purpose of altering provisions of the ethics law governing the period of time during
4 which former members of the General Assembly are prohibited from representing or
5 assisting certain parties for compensation in certain matters; ~~prohibiting, except~~
6 ~~under certain circumstances, former officials and employees of the Legislative~~
7 ~~Branch and Executive Branch from representing or assisting certain parties for~~
8 ~~compensation in certain matters for a certain period of time; prohibiting an official~~
9 ~~from directly or indirectly initiating a solicitation for a person to retain the services~~
10 ~~of a particular regulated lobbyist or lobbying firm; prohibiting a member of the~~
11 ~~General Assembly from taking certain actions relating to legislation affecting certain~~
12 ~~entities; requiring a legislator to report certain information to the State Ethics~~
13 ~~Commission on or before the first day of a legislator's term and within a certain~~
14 ~~number of days of any change in information occurring, rather than to the Joint~~
15 ~~Ethics Committee and at the times and in the manner required by the Committee;~~

20 (c) A public employee may not demand or receive a bribe, fee, reward, or
 21 testimonial to:

- 22 (1) influence the performance of the official duties of the public employee; or
 23 (2) neglect or fail to perform the official duties of the public employee.

24 (d) A person who violates this section is guilty of the misdemeanor of bribery and
 25 on conviction:

26 (1) is subject to imprisonment for not less than 2 years and not exceeding 12
 27 years or a fine not less than ~~[\$100]~~\$1,000 and not exceeding ~~[\$5,000]~~\$10,000 or both;

1 (i) an interest held in the capacity of agent, custodian, fiduciary,
 2 personal representative, or trustee, unless the holder has an equitable interest in the
 3 subject matter;

4 (ii) an interest in a time or demand deposit in a financial institution;

5 (iii) an interest in an insurance policy, endowment policy, or annuity
 6 contract under which an insurer promises to pay a fixed amount of money in a lump sum
 7 or periodically for life or a specified period;

8 (iv) a common trust fund or a trust that forms part of a pension or a
 9 profit-sharing plan that:

10 1. has more than 25 participants; and

11 2. is determined by the Internal Revenue Service to be a
 12 qualified trust under the Internal Revenue Code or a qualified tuition plan established
 13 pursuant to Section 529 of the Internal Revenue Code; or

14 (v) a mutual fund OR EXCHANGE-TRADED FUND that is publicly
 15 traded on a national scale unless the mutual fund OR EXCHANGE-TRADED FUND is
 16 composed primarily of holdings of stocks and interests in a specific sector or area that is
 17 regulated by the individual's governmental unit.

24 the official or employee, or of a qualifying relative of the official or employee, with respect
25 to a thing of economic value; and

27 and substantially the interest of the official, employee, or qualifying relative.

10 (b) Except as provided in subsections (c) and (d) of this section, an official or
11 employee may not:

12 (1) be employed by or have a financial interest in:

13 (i) an entity subject to the authority of that official or employee or
14 of the governmental unit with which the official or employee is affiliated; or

15 (ii) an entity that is negotiating or has entered a contract with that
16 governmental unit or an entity that is a subcontractor on a contract with that governmental
17 unit; or

18 (2) hold any other employment relationship that would impair the

10 1. recruit and hire highly qualified or uniquely qualified
 11 professionals for public service; or

12 2. assure the availability of competent services to the public;

14 (ii) the number of exemptions granted under this subsection has not

(g) (1) The statement shall include a schedule, to the extent the individual may reasonably be expected to know, of each debt, excluding retail credit accounts, owed at any time during the applicable period to entities doing business with [the State] OR REGULATED BY THE INDIVIDUAL'S GOVERNMENTAL UNIT:

(i) by the individual; and

(ii) if the individual was involved in the transaction giving rise to the debt, by any member of the immediate family of the individual.

(2) For each debt, the schedule shall include:

3 OF THE HOUSE;

4 (II) TWO MEMBERS OF THE PUBLIC, APPOINTED BY THE

7 SPEAKER OF THE HOUSE.
