A BILL ENTITLED

1 AN ACT concerning

2 **Garrett County – Alcoholic Beverages – Licenses and Sunday Sales**

3 FOR the purpose of altering the underlying licenses that may be held by a recipient of a
4 Class BDR (deluxe restaurant) beer and wine license issued in Garrett County;
5 altering the alcoholic beverages that may be sold for on–premises consumption and
6 off–premises consumption at a hotel, motel, or restaurant; altering certain catering
7 options for certain licenses; altering certain restrictions regarding a license for use
8 by a deluxe restaurant; repealing certain Sunday license fees for certain licenses;
9 altering the hours of sale on Sunday for certain licenses; allowing the holder of a
10 certain Class C license to purchase certain alcoholic beverages from a retailer;
11 specifying that a requirement for a criminal history records check may apply to an
12 applicant for license renewal; authorizing a holder of a Class B beer license to sell
13 beer on certain days during certain hours; specifying certain license holders that may
14 sell alcoholic beverages on Sunday under certain circumstances; making certain
15 technical changes; clarifying certain language; and generally relating to alcoholic
16 beverages licenses and Sunday sales of alcoholic beverages in Garrett County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Alcoholic Beverages**

4 21–102.

5 This title applies only in Garrett County.

6 21–803.

7 (a) There is a Class BDR (deluxe restaurant) beer and wine license.

8 (b) The license may be issued to a holder of a Class B beer **LICENSE OR A CLASS**
9 **B BEER** and wine license [or a Class B beer, wine, and liquor license].

10 21–902.

11 (a) There is a Class B beer, wine, and liquor license.

12 (e) The license authorizes the license holder to sell [beer, wine, and liquor] at a
13 hotel, motel, or restaurant at retail at the place described in the license[, for on–premises
14 consumption]:

15 **(1) BEER, WINE, AND LIQUOR FOR ON–PREMISES CONSUMPTION; AND**

16 **(2) BEER FOR OFF–PREMISES CONSUMPTION.**

17 (f) (1) The catering option authorizes the license holder to sell beer, wine, and
18 liquor for consumption at events catered by the license holder in the county off the licensed
19 premises.

20 (2) A license holder providing alcoholic beverages at a catered event off the
21 licensed premises shall also provide food.

22 (3) [A holder of a license with the catering option may sell beer for
23 off–premises consumption from the licensed premises but may not sell beer for
24 off–premises consumption at a catered event held off the licensed premises.

25 (4)] The license holder may exercise catering privileges only during hours
26 and days that are authorized under the Class B license.

27 21–903.

28 (a) There is a Class BDR (deluxe restaurant) beer, wine, and liquor license.

1 (b) The Board may issue the license to a holder of:

2 **(1) A CLASS B BEER AND WINE LICENSE;**

3 ~~[(1)]~~**(2)** a Class B beer, wine, and liquor license; or

4 ~~[(2)]~~**(3)** a Class B Resort beer, wine, and liquor license.

5 (c) (1) The Board may issue the license for use by a deluxe restaurant as
6 defined by the Board with:

7 (i) seating **AT TABLES, NOT INCLUDING SEATS AT BARS OR**
8 **COUNTERS**, for at least 85 individuals; and

9 (ii) a capital investment of at least \$250,000 for the restaurant
10 facilities, not including the cost of land or buildings.

11 (2) If an applicant purchases or leases an existing building, the capital
12 investment attributable to the cost of the land and improvements shall be based on the
13 assessed value of the land and improvements in accordance with the records of the State
14 Department of Assessments and Taxation at the time of purchase or lease.

15 **(3) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL, AT**
16 **RETAIL, AT THE PLACE DESCRIBED IN THE LICENSE:**

17 **(I) BEER, WINE, AND LIQUOR FOR ON-PREMISES**
18 **CONSUMPTION; AND**

19 **(II) BEER FOR OFF-PREMISES CONSUMPTION.**

20 (d) **(1) A license holder of a Class BDR license may acquire [the] A catering**
21 **option [authorized under § 21-902 of this subtitle] THAT AUTHORIZES THE LICENSE**
22 **HOLDER TO SELL BEER, WINE, AND LIQUOR FOR CONSUMPTION AT EVENTS CATERED**
23 **BY THE LICENSE HOLDER IN THE COUNTY OFF THE LICENSED PREMISES.**

24 **(2) A LICENSE HOLDER PROVIDING ALCOHOLIC BEVERAGES AT A**
25 **CATERED EVENT OFF THE LICENSED PREMISES SHALL ALSO PROVIDE FOOD.**

26 **(3) THE LICENSE HOLDER MAY EXERCISE CATERING PRIVILEGES**
27 **ONLY DURING HOURS AND DAYS THAT ARE AUTHORIZED UNDER THE CLASS B**
28 **LICENSE.**

29 (e) [The license holder may sell beer, wine, and liquor during the hours and days
30 of sale as set out in § 21-2004(d) of this title.

1 (f)] The annual license fees are:

2 (1) \$2,250 for a 6-day license without a catering option;

3 (2) \$2,750 for a 6-day license with a catering option;

4 (3) \$2,625 for a 7-day license without a catering option; and

5 (4) \$3,125 for a 7-day license with a catering option.

6 [(g)] (F) The Board shall charge a one-time issuing fee for a new license in an
7 amount equal to the annual license fee.

8 21-904.

9 (b) There is a Class C (club and organization) beer, wine, and liquor license.

10 (f) (1) This subsection applies only in:

11 (i) election districts 11 and 15; and

12 (ii) any other election district or precinct of an election district in
13 which the voters in a referendum authorized by law approve Sunday sales.

14 (2) The license holder may sell beer, wine, and liquor on Sunday during the
15 hours as set out under § 21-2004(e)(2) of this title.

16 [(3) In addition to the fees specified in subsection (g) of this section, fees for
17 exercising the privileges of the license on Sunday are:

18 (i) \$250, as an annual license fee; and

19 (ii) \$250, as an issuance fee for a new license.]

20 21-905.

21 (a) (1) There is:

22 (i) a Class D (75% on-sale) beer, wine, and liquor license; and

23 (ii) a Class D (75% off-sale) beer, wine, and liquor license.

24 (d) (1) [A holder of the license without a catering option may sell beer, wine,
25 and liquor for on- or off-premises consumption.

1 (2) A holder of the license with a catering option may sell beer, wine, and
2 liquor[:

3 (i) for on- or off-premises consumption; and

4 (ii) subject to paragraph (3) of this subsection,] for consumption at
5 events that the holder caters off the licensed premises during the hours and days that the
6 Board allows.

7 [(3) (2) The license holder shall provide food if the license holder
8 provides alcoholic beverages at a catered event off the licensed premises.

9 21-1002.

10 (a) There is a Class B-resort beer, wine, and liquor license.

11 (c) The license authorizes the license holder to [exercise the same privileges as a
12 license holder of a regular Class B hotels and restaurants beer, wine, and liquor license]
13 **SELL AT A HOTEL, MOTEL, OR RESTAURANT AT RETAIL AT THE PLACE DESCRIBED IN**
14 **THE LICENSE:**

15 (1) **BEER, WINE, AND LIQUOR FOR ON-PREMISES CONSUMPTION; AND**

16 (2) **BEER FOR OFF-PREMISES CONSUMPTION.**

17 21-1304.

18 (a) (1) There is a beer festival license.

19 (f) Notwithstanding subsection (e)(1) of this section, a holder of a beer festival
20 license issued for a location at which Sunday sales are allowed under § 21-2002(e) of this
21 title may make Sunday sales[:

22 (1) beginning at [1 p.m.; and

23 (2) without a consumer placing an order for a meal before or with an order
24 for an alcoholic beverage.] **10 A.M.**

25 21-1305.

26 (a) (1) There is a wine festival license.

27 (b) The Board may issue the license to:

28 (1) a holder of a retail license, Class 3 winery license, or Class 4 limited
29 winery license; or

1 (2) a person that is eligible to hold [any type of] **A Class C MULTIPLE DAY**
2 **OR MULTIPLE EVENT** license [that the Board issues].

3 (g) Notwithstanding subsection (f)(3)(i) of this section, a holder of a wine festival
4 license issued for use in a location where Sunday sales are allowed [under § 21–2001(e) of
5 this title] may make Sunday sales[:

6 (1) beginning at 10 a.m. [; and

7 (2) without a consumer placing an order for a meal before or with an order
8 for an alcoholic beverage.]

9 21–1309.

10 (a) The Board may issue a Class C multiple day beer license, beer and wine
11 license, and beer, wine, and liquor license **TO A CLUB** for the following fees and license
12 types:

13 (1) \$50 for a 2–day license;

14 (2) \$150 for a 6–day license; and

15 (3) \$300 for a 12–day license.

16 21–1312.

17 A holder of a Class C per diem beer, wine, and liquor license may purchase beer and
18 wine from a wholesaler **OR BEER, WINE, AND LIQUOR FROM A RETAILER.**

19 21–1804.

20 The requirement for a criminal history records check under § 4–107 of this article
21 [applies] **MAY APPLY** to an applicant for a license renewal.

22 21–2002.

23 (a) This section does not apply to the hours of sale on December 31 and January

26 from 6 a.m. to 2 a.m. the following day.

27 (c) **A HOLDER OF A CLASS B BEER LICENSE MAY SELL BEER ON MONDAY**
28 **THROUGH SATURDAY FROM 6 A.M. TO 2 A.M. THE FOLLOWING DAY.**

1 (d) Reserved.

2 (e) [(1)] A holder of a Class D beer license may sell beer on Monday through
3 Saturday from 6 a.m. to 2 a.m. the following day.

4 [(2) (i) (F) [Subject to subparagraph (ii) of this paragraph,] Sunday
5 sales **FOR A CLASS A, CLASS B, OR CLASS D LICENSE** are allowed from [1 p.m.] **10 A.M.**
6 to [10 p.m.] **MIDNIGHT** in:

7 [1.] (1) election districts 11 and 15; and

8 [2.] (2) any other election district or precinct of an election
9 district in which the voters in a referendum authorized by law approve Sunday sales as
10 specified in this paragraph.

11 [(ii) A holder of a Class D beer license may sell beer on Sunday for
12 on-premises consumption if the licensed premises:

13 1. is in a permanent building;

14 2. has a seating capacity at tables, not including seats at bars
15 or counters, for at least 20 individuals;

16 3. is equipped with a full-service commercial kitchen capable
17 of preparing and serving full-course meals for at least 20 individuals at one seating; and

18 4. is approved by the Board, the Department of Public
19 Utilities, the Health Department, and the Planning and Land Development Office of the
20 county.

21 (iii) Sunday sales are allowed from 1 p.m. to 10 p.m.

22 (iv) In addition to the usual license fee, fees for exercising the
23 privileges of the license on Sunday are:

24 1. \$250, as an annual license fee; and

25 2. \$250, as an issuing fee for a new license.]

26 21-2003.

27 (a) This section does not apply to the hours of sale on December 31 and January
28 1 set out in § 21-2007 of this subtitle.

29 (b) (1) A holder of a Class A beer and wine license may sell beer and wine on
30 Monday through Saturday, from 6 a.m. to 2 a.m. the following day.

1 **(2) SUNDAY SALES ARE ALLOWED FROM 10 A.M. TO MIDNIGHT IN:**

2 **(I) ELECTION DISTRICTS 11 AND 15; AND**

3 **(II) ANY OTHER ELECTION DISTRICT OR PRECINCT OF AN**

13 specified in this paragraph.

14 **[(ii)]** In addition to the usual license fee, fees for exercising the
15 privileges of the license on Sunday are:

26 specified in this paragraph.

27 **[(ii)]** A holder of a Class D beer and wine license may sell beer and
28 wine on Sunday for on-premises consumption if the licensed premises:

- 1 1. is in a permanent building;
- 2 2. has a seating capacity at tables, not including seats at bars
3 or counters, for at least 20 individuals;
- 4 3. is equipped with a full-service commercial kitchen capable
5 of preparing and serving full-course meals for at least 20 individuals at one seating; and
- 6 4. is approved by the Board, the Department of Public
7 Utilities, the Health Department, and the Planning and Land Development Office of the
8 county.

9 (iii) In addition to the usual license fee, fees for exercising the

21 **MIDNIGHT** in:

22 [1.] **(I)** election districts 11 and 15; and

23 [2.] **(II)** any other election district or precinct of an election
24 district in which the voters in a referendum authorized by law approve Sunday sales as
25 specified in this paragraph.

26 [(ii) In addition to the usual license fee, fees for exercising the
27 privileges of the license on Sunday are:

8 APPROVE SUNDAY SALES AS SPECIFIED IN THIS PARAGRAPH.

9 (e) (1) A holder of a Class C beer, wine, and liquor license may sell beer, wine,

17 privileges of the license on Sunday are:

18 1. \$250 in addition to the usual license fee; and

19 2. \$250, as an issuing fee for a new license.]

20 (f) (1) A holder of a Class D beer, wine, and liquor license may sell beer, wine,
21 and liquor on Monday through Saturday, from 6 a.m. to 2 a.m. the following day.

22 (2) [(i) Subject to subparagraph (ii) of this paragraph,] Sunday sales are
23 allowed from [1 p.m.] 10 A.M. to [10 p.m.] MIDNIGHT in:

24 [1.] (I) election districts 11 and 15; and

25 [2.] (II) any other election district or precinct of an election
26 district in which the voters in a referendum authorized by law approve Sunday sales as
27 specified in this paragraph.

28 [(ii) A holder of a Class D beer, wine, and liquor license may sell beer,
29 wine, and liquor on Sunday for on-premises consumption if the licensed premises:

1 (2) A holder of a license listed in paragraph (1) of this subsection may sell
 2 alcoholic beverages for off-premises consumption on a Sunday if the license holder may sell
 3 alcoholic beverages for off-premises consumption for the underlying license.

4 (C) (1) **THIS SUBSECTION APPLIES TO ON-PREMISES SALES BY:**

5 (I) **A HOLDER OF A CLASS B LICENSE, INCLUDING A CLASS**
 6 **B&B LICENSE, CLASS BDR LICENSE, AND RESORT LICENSE;**

7 (II) **A HOLDER OF A CLASS C LICENSE;**

8 (III) **A HOLDER OF A MULTIPLE DAY OR MULTIPLE EVENT**
 9 **LICENSE; AND**

10 (IV) **A HOLDER OF A CLASS D LICENSE.**

11 (2) **A HOLDER OF A LICENSE SPECIFIED IN PARAGRAPH (1) OF THIS**
 12 **SUBSECTION MAY SELL ALCOHOLIC BEVERAGES FOR ON-PREMISES CONSUMPTION**
 13 **ON SUNDAY IF THE LICENSE HOLDER IS AUTHORIZED BY THE UNDERLYING LICENSE**
 14 **TO SELL ALCOHOLIC BEVERAGES FOR ON-PREMISES CONSUMPTION.**

15 [(c)] (3) Sunday sales authorized under this [section] SUBSECTION are from [1
 16 p.m.] **10 A.M.** to [10 p.m.] **MIDNIGHT.**

17 [(d)] (1) This subsection does not apply to a holder of a Class C license.

18 (2) The Sunday sales fee is \$250 for the holder of a Class A license, Class
 19 B license, or Class D license.

20 (3) When the Class A license, Class B license, or Class D license is issued,
 21 the Board shall charge a \$250 issuing fee.]

22 21-2102.

23 (a) In addition to the grounds for suspension in § 4-604 of this article, the Board
 24 may suspend a license for a time not exceeding 1 year for:

25 (1) the sale of alcoholic beverages to an individual under the age of 21
 26 years; or

27 (2) the sale on Sunday of alcoholic beverages in an election district **OR A**
 28 **PRECINCT OF AN ELECTION DISTRICT** in which Sunday sales have not been authorized
 29 by a voter referendum.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
2 1, 2017.
