Correctional Officers' Retirement System – Membership

- 3 FOR the purpose of altering the membership of the Correctional Officers' Retirement 4 System to include certain individuals serving in certain positions in the Department $\mathbf{5}$ of Public Safety and Correctional Services; providing that certain members of the 6 Correctional Officers' Retirement System who meet certain criteria may receive a 7 normal service retirement allowance that is based on certain creditable service; 8 requiring the State Retirement Agency, on or before a certain date, to notify certain 9 individuals affected by this Act of their right to transfer certain service credit to the 10 Correctional Officers' Retirement System; and generally relating to membership in 11 the Correctional Officers' Retirement System.

2 (I) a correctional case management specialist, supervisor, or 3 manager who has a combined total of 20 years of eligibility service as provided in subsection 4 (a)(1)(ii) of this section; **OR**

5 (II) A MEMBER SERVING IN A POSITION SPECIFIED IN § 6 25–201(A)(8) OF THIS TITLE WHO HAS A COMBINED TOTAL OF 20 YEARS OF 7 ELIGIBILITY SERVICE AS PROVIDED IN SUBSECTION (A)(1)(III) OF THIS SECTION.

8 (2) A member is entitled to receive a normal service retirement allowance 9 that equals an allowance based on the creditable service the member has in the 10 Correctional Officers' Retirement System.

11 SECTION 2. AND BE IT FURTHER ENACTED, That, on or before October 1, 2017, 12 the State Retirement Agency shall notify the individuals who are affected by this Act of 13 their right to transfer service credit from the Employees' Retirement System or the 14 Employees' Pension System to the Correctional Officers' Retirement System.

15 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July16 1, 2017.
