A BILL ENTITLED

1 AN ACT concerning

2 **Health Occupations – Dental Therapists – Licensure**

3 FOR the purpose of requiring the State Board of Dental Examiners to adopt regulations for
4 the licensure of dental therapists and the practice of dental therapy; requiring the
5 Board to adopt regulations establishing criteria for taking certain action relating to
6 a collaboration agreement; requiring the Board to adopt a code of ethics for the
7 practice of dental therapy; requiring the Board to set certain fees and to pay all fees
8 collected to the Comptroller; requiring the Comptroller to distribute all fees to the
9 State Board of Dental Examiners Fund; requiring, with certain exceptions and
10 beginning on a certain date, that an individual be licensed by the Board before the
11 individual may practice dental therapy in the State; providing for the construction
12 of certain provisions of this Act; requiring that a license issued to a dental therapist
13 limit the dental therapist's scope of practice to certain acts; specifying the patient
14 services that may be provided by a dental therapist under a collaboration agreement
15 with a supervising dentist; prohibiting a dentist from supervising a dental therapist
16 in the performance of delegated acts without filing a completed collaboration
17 agreement with the Board; prohibiting a dental therapist from performing certain
18 acts; providing that a dental therapist is the agent of the supervising dentist in the
19 performance of certain activities; authorizing a dentist to delegate acts to a dental
20 therapist only after a collaboration agreement has been executed, filed with, and
21 approved by the Board; requiring that the collaboration agreement be consistent
22 with certain standards, include certain items, set forth certain expectations, and be
23 signed and maintained by the supervising dentist and the dental therapist and
24 updated as necessary, with certain approval; limiting the number of dental
25 therapists with whom a supervising dentist may have a collaboration agreement;
26 authorizing the Board to take certain action relating to a collaboration agreement;
27 requiring the Board to notify the supervising dentist and the dental therapist in a
28 certain manner if the Board takes a certain action relating to the collaboration
29 agreement; prohibiting the Board from restricting the submission of an amendment
30 to the collaboration agreement; requiring the Board, to the extent practicable, to take
31 certain action within a certain time period after receiving a completed collaboration

1 agreement; authorizing the Board to take certain action if the Board determines that
2 a supervising dentist or dental therapist is practicing in a certain manner;
3 authorizing a dental therapist to practice only in accordance with a collaboration
4 agreement filed with the Board; establishing the qualifications that an applicant
5 must meet to qualify for a license to practice dental therapy and for a dental
6 therapist licensed in another state to obtain a license; requiring an applicant to
7 submit a certain application and pay a certain fee to apply for a license to practice
8 dental therapy; requiring the Board to issue a license to a certain applicant;
9 providing that a license authorizes an individual to practice as a dental therapist in
10 the State under a collaboration agreement while the license is effective; authorizing
11 a dental therapist to practice under the general supervision of a dentist except under
12 certain circumstances; providing for the renewal and reinstatement of a dental
13 therapist license; requiring a licensed dental therapist to notify the Board in writing
14 of a change in name or address within a certain period of time; prohibiting a licensed
15 dental therapist from surrendering a license and prohibiting the lapse of a license
16 under certain circumstances; authorizing the Board to take certain disciplinary
17 action against an applicant or a licensee for certain reasons; authorizing the Board
18 to impose a certain fine on a licensee under certain circumstances; requiring the
19 Board to adopt regulations to set certain standards; requiring the Board to pay a
20 certain fine into the General Fund of the State; requiring the Board to give a certain
21 individual an opportunity for a hearing before the Board and to give certain notice
22 and hold the hearing in accordance with certain provisions of law; authorizing the
23 Board to issue subpoenas and administer oaths under certain circumstances;
24 authorizing a certain court to take certain action against an individual who disobeys
25 a subpoena from the Board or an order by the Board; authorizing the Board to hear
26 and determine a certain matter under certain circumstances; authorizing an
27 individual aggrieved by a decision of the Board to take certain action under certain
28 circumstances; authorizing the Board to reinstate the certificate of an individual
29 whose license has been revoked; prohibiting an individual from practicing,
30 attempting to practice, or offering to practice dental therapy in the State without a
31 license; establishing certain penalties for violations of certain provisions of this Act;
32 establishing a certain short title; requiring the Board to report certain information
33 to certain committees of the General Assembly on or before certain dates; stating the
34 intent of the General Assembly regarding the initial funding of the Board and the
35 reimbursement to the General Fund for certain costs, under certain circumstances;
36 defining certain terms; and generally relating to licensing of dental therapists and
37 the State Board of Dental Examiners.

44 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

45 That the Laws of Maryland read as follows:

2 SUBTITLE 6A. DENTAL THERAPISTS.

4 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS
5 INDICATED.

6 (B) “COLLABORATION AGREEMENT” MEANS A DOCUMENT THAT IS
7 EXECUTED BY A SUPERVISING DENTIST AND A DENTAL THERAPIST AND MEETS THE
8 REQUIREMENTS OF § 4–6A–06(C) OF THIS SUBTITLE.

9 (C) “DENTAL THERAPIST” MEANS AN INDIVIDUAL WHO HOLDS A LICENSE
10 TO PRACTICE DENTAL THERAPY IN THE STATE.

11 (D) “DIRECT SUPERVISION” MEANS SUPERVISION BY A LICENSED DENTIST
12 WHO IS READILY AVAILABLE AT THE PRACTICE SITE OF A DENTAL THERAPIST FOR
13 CONSULTATION OR INTERVENTION.

14 (E) “GENERAL SUPERVISION” MEANS SUPERVISION BY A LICENSED
15 DENTIST WHO MIGHT NOT BE PHYSICALLY PRESENT AT THE PRACTICE SITE OF A
16 DENTAL THERAPIST.

17 (F) “PRACTICE DENTAL THERAPY” MEANS TO PROVIDE ORAL HEALTH CARE
18 SERVICES, INCLUDING PREVENTIVE, ORAL EVALUATION AND ASSESSMENT,
19 EDUCATIONAL, PALLIATIVE, THERAPEUTIC, AND RESTORATIVE SERVICES, AS
20 AUTHORIZED IN AN APPROVED COLLABORATION AGREEMENT WITH A SUPERVISING
21 DENTIST.

18 OTHER STATE OR COUNTRY WHILE THE INDIVIDUAL MAKES A CLINICAL
19 DEMONSTRATION BEFORE A DENTAL SOCIETY, DENTAL CONVENTION, OR DENTAL
20 THERAPY CLASS.21 **4-6A-05.**22 (A) THIS SUBTITLE MAY NOT BE CONSTRUED TO AUTHORIZE A DENTAL
23 THERAPIST TO PRACTICE INDEPENDENTLY OF A SUPERVISING DENTIST.24 (B) A LICENSE ISSUED TO A DENTAL THERAPIST SHALL LIMIT THE DENTAL
25 THERAPIST'S SCOPE OF PRACTICE TO ACTS:26 (1) SPECIFIED IN THE COLLABORATION AGREEMENT ENTERED INTO
27 BY THE SUPERVISING DENTIST AND THE DENTAL THERAPIST AND FILED WITH THE
28 BOARD;

1 **(2) APPROPRIATE TO THE EDUCATION, TRAINING, AND EXPERIENCE**
2 **OF THE DENTAL THERAPIST; AND**

3 **(3) CUSTOMARY TO THE PRACTICE OF THE SUPERVISING DENTIST.**

4 **(C) PATIENT SERVICES THAT MAY BE PROVIDED BY A DENTAL THERAPIST**
5 **UNDER A COLLABORATION AGREEMENT WITH A SUPERVISING DENTIST INCLUDE:**

6 **(1) ANY ACTS WITHIN THE SCOPE OF PRACTICE OF A LICENSED**
7 **DENTAL HYGIENIST;**

8 **(2) ANY SERVICES AND PROCEDURES INCLUDED IN THE COMMISSION**
9 **ON DENTAL ACCREDITATION DENTAL THERAPY STANDARDS;**

10 **(3) INTERPRETATION OF RADIOGRAPHS;**

11 **(4) PLACEMENT OF SPACE MAINTAINERS;**

12 **(5) PULPOTOMIES ON PRIMARY TEETH;**

13 **(6) AN ORAL EVALUATION AND ASSESSMENT OF DENTAL DISEASE**
14 **AND THE FORMATION OF AN INDIVIDUALIZED TREATMENT PLAN;**

15 **(7) NONSURGICAL EXTRACTIONS OF ERUPTED, PERIODONTALLY**
16 **DISEASED PERMANENT TEETH WITH TOOTH MOBILITY OF +3; AND**

17 **(8) ANY OTHER SERVICES AS AUTHORIZED IN THE COLLABORATION**
18 **AGREEMENT.**

19 **(D) (1) A DENTIST MAY NOT SUPERVISE A DENTAL THERAPIST IN THE**
20 **PERFORMANCE OF DELEGATED ACTS WITHOUT FILING A COMPLETED**
21 **COLLABORATION AGREEMENT WITH THE BOARD.**

22 **(2) A DENTAL THERAPIST MAY NOT PERFORM ANY DENTAL ACT FOR**
23 **WHICH:**

24 **(I) THE INDIVIDUAL HAS NOT BEEN LICENSED; AND**

25 **(II) THE DENTAL ACTS HAVE NOT BEEN DELEGATED BY A**
26 **SUPERVISING DENTIST.**

27 **(E) A DENTAL THERAPIST IS THE AGENT OF THE SUPERVISING DENTIST IN**
28 **THE PERFORMANCE OF ALL PRACTICE-RELATED ACTIVITIES, INCLUDING THE**

1 ORAL, WRITTEN, AND ELECTRONIC ORDERING OF DIAGNOSTIC, THERAPEUTIC, AND
2 ANY OTHER DENTAL SERVICES.

4 (A) A DENTIST MAY DELEGATE ACTS TO A DENTAL THERAPIST ONLY AFTER
5 A COLLABORATION AGREEMENT HAS BEEN EXECUTED, FILED WITH, AND APPROVED
6 BY THE BOARD.

7 (B) THE COLLABORATION AGREEMENT SHALL BE CONSISTENT WITH ANY
8 STANDARDS ESTABLISHED BY THE COMMISSION ON DENTAL ACCREDITATION.

9 (C) THE COLLABORATION AGREEMENT SHALL INCLUDE:

10 (1) THE PRACTICE SETTINGS IN WHICH THE DENTAL THERAPIST MAY
11 PROVIDE SERVICES;

12 (2) THE EXTENT TO WHICH THE DENTAL THERAPIST MAY SUPERVISE
13 DENTAL ASSISTANTS;

14 (3) ANY LIMITATION ON SERVICES THAT MAY BE PROVIDED BY THE
15 DENTAL THERAPIST;

16 (4) THE LEVEL OF SUPERVISION REQUIRED FOR PARTICULAR
17 SERVICES OR PRACTICE SETTINGS; AND

18 (5) PRACTICE PROTOCOLS, INCLUDING:

19 (I) AGE- AND PROCEDURE-SPECIFIC PRACTICE PROTOCOLS,
20 INCLUDING CASE SELECTION CRITERIA, ASSESSMENT GUIDELINES, AND IMAGING
21 FREQUENCY;

22 (II) PROCEDURES FOR CREATING AND MAINTAINING RECORDS
23 FOR PATIENTS TREATED BY THE DENTAL THERAPIST;

24 (III) PROCEDURES FOR MANAGING MEDICAL EMERGENCIES IN
25 EACH PRACTICE SETTING IN WHICH THE DENTAL THERAPIST PROVIDES CARE;

26 (IV) A QUALITY ASSURANCE PLAN FOR MONITORING CARE
27 PROVIDED BY THE DENTAL THERAPIST, INCLUDING PATIENT REVIEW AND
28 REFERRAL FOLLOW-UP;

1 (V) CRITERIA RELATING TO THE PROVISION OF CARE TO
2 PATIENTS WITH SPECIFIC MEDICAL CONDITIONS OR COMPLEX MEDICATION
3 HISTORIES, INCLUDING REQUIREMENTS FOR CONSULTATION BEFORE THE
4 INITIATION OF CARE;

5 (VI) PROTOCOLS TO GOVERN SITUATIONS IN WHICH THE
6 DENTAL THERAPIST ENCOUNTERS A PATIENT WHO REQUIRES TREATMENT THAT
7 EXCEEDS THE AUTHORIZED SCOPE OF PRACTICE OF THE DENTAL THERAPIST;

8 (VII) A PLAN FOR THE PROVISION OF CLINICAL RESOURCES; AND

9 (VIII) CRITERIA FOR THE SUPERVISION OF DENTAL ASSISTANTS
10 BY DENTAL THERAPISTS.

11 (D) THE COLLABORATION AGREEMENT SHALL SET FORTH CLEAR
12 EXPECTATIONS FOR THE ESTABLISHMENT OF A PERMANENT DENTAL HOME THAT:

13 (1) PROMOTES REGULAR VISITS WITH THE SUPERVISING DENTIST;

14 (2) FACILITATES ACCESSIBLE COMMUNICATION BETWEEN THE
15 SUPERVISING DENTIST AND THE PATIENT; AND

16 (3) ENSURES CONTINUITY OF CARE.

17 (E) A COLLABORATION AGREEMENT SHALL BE SIGNED AND MAINTAINED BY
18 THE SUPERVISING DENTIST AND THE DENTAL THERAPIST AND UPDATED AS
19 NECESSARY, WITH THE APPROVAL OF THE BOARD.

20 (F) A SUPERVISING DENTIST MAY HAVE A COLLABORATION AGREEMENT
21 WITH NOT MORE THAN SIX DENTAL THERAPISTS AT THE SAME TIME.

22 (G) (1) THE BOARD, IN ACCORDANCE WITH THE CRITERIA ESTABLISHED
23 IN REGULATION:

24 (I) MAY APPROVE THE COLLABORATION AGREEMENT; OR

25 (II) MAY MODIFY OR DISAPPROVE THE COLLABORATION
26 AGREEMENT.

27 (2) IF THE BOARD MODIFIES OR DISAPPROVES THE COLLABORATION
28 AGREEMENT, THE BOARD:

1 **(I) SHALL NOTIFY THE SUPERVISING DENTIST AND THE**
2 **DENTAL THERAPIST IN WRITING OF THE PARTICULAR ELEMENTS OF THE PROPOSED**
3 **COLLABORATION AGREEMENT THAT WERE THE CAUSE FOR THE MODIFICATION OR**
4 **DISAPPROVAL; AND**

5 **(II) MAY NOT RESTRICT THE SUBMISSION OF AN AMENDMENT**
6 **TO THE COLLABORATION AGREEMENT.**

7 **(H) TO THE EXTENT PRACTICABLE, THE BOARD SHALL APPROVE A**
8 **COLLABORATION AGREEMENT OR TAKE OTHER ACTION AUTHORIZED UNDER THIS**
9 **SECTION WITHIN 90 DAYS AFTER RECEIVING A COMPLETED COLLABORATION**
10 **AGREEMENT, INCLUDING ANY INFORMATION FROM THE DENTAL THERAPIST AND**
11 **THE SUPERVISING DENTIST NECESSARY TO APPROVE OR TAKE ACTION.**

12 **(I) IF THE BOARD DETERMINES THAT A SUPERVISING DENTIST OR DENTAL**
13 **THERAPIST IS PRACTICING IN A MANNER INCONSISTENT WITH THE REQUIREMENTS**
14 **OF THIS TITLE, THE BOARD MAY:**

15 **(1) DEMAND MODIFICATION OF THE PRACTICE;**

16 **(2) WITHDRAW THE APPROVAL OF THE COLLABORATION**
17 **AGREEMENT; OR**

18 **(3) REFER THE MATTER TO THE BOARD FOR THE PURPOSE OF**
19 **TAKING OTHER DISCIPLINARY ACTION UNDER § 4-315 OF THIS TITLE OR § 4-6A-18**
20 **OF THIS SUBTITLE.**

21 **(J) A DENTAL THERAPIST MAY PRACTICE ONLY IN ACCORDANCE WITH A**
22 **COLLABORATION AGREEMENT FILED WITH THE BOARD UNDER THIS SUBTITLE.**

5 **THAT MEETS THE STANDARDS OF THE COMMISSION ON DENTAL ACCREDITATION;**

6 **(2) ADDRESSES THE DENTAL CARE NEEDS OF PATIENTS WITH**
7 **SPECIAL NEEDS, INCLUDING:**

8 **(I) INDIVIDUALS WHOSE MEDICAL, PHYSICAL,**
9 **PSYCHOLOGICAL, COGNITIVE, OR SOCIAL SITUATIONS MAKE IT NECESSARY TO**
