## **HOUSE BILL 1244**

Health Service, the National Oceanic and Atmospheric Administration, or the Coast and 18 19 Geodetic Survey. 20 (2) The subtraction under subsection (a) of this section includes [: 21if, on the last day of the taxable year, the individual is under the (i) 22age of 65 years, the first \$5,000 of military retirement income received by an individual 23 during the taxable year; and 24if, on the last day of the taxable year, the individual is at least 65 (ii) years old, the first \$10,000 of military retirement income received by an individual during 2526 the taxable year. 27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2017, and shall be applicable to all taxable years beginning after December 31, 2016. 28
