- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 15 That the Laws of Maryland read as follows:

16 Article – Transportation

- 18 (a) (1) When registered with the Administration, every trailer and semitrailer 19 is a Class G (trailer) vehicle.
- 20 (2) A Class G (trailer) vehicle shall be classified as "freight" or "nonfreight".
- 21 (b) A nonfreight trailer or semitrailer is a vehicle designed for towing by a Class
- 22 A (passenger) vehicle, a Class M (multipurpose) vehicle, or a Class E (truck) vehicle, and
- 23 shall:

- 1 (1) (i) If towed by a Class E (truck) vehicle, have a gross weight of 2 20.000 pounds or less; or
- 3 (ii) If towed by a Class A (passenger) vehicle or a Class M 4 (multipurpose) vehicle, have a gross weight of 10,000 pounds or less; and
- 5 (2) Be a:
- 6 (i) Boat trailer;
- 7 (ii) Camping trailer;
- 8 (iii) Travel trailer;
- 9 (iv) House trailer; or
- 10 (v) Utility trailer.
- 11 (c) A freight trailer or semitrailer shall be:
- 12 (1) Designed for towing by a Class E (truck) or Class F (tractor) vehicle;
- 13 and
- 14 (2) (i) In excess of 20,000 pounds gross weight if towed by a Class E
- 15 (truck) vehicle; or
- 16 (ii) In excess of 10,000 pounds gross weight if towed by a Class F
- 17 (tractor) vehicle.
- 18 (d) The annual registration fee for a Class G (trailer) vehicle is based on the
- 19 maximum gross weight as follows:
- 20 (1) Except as provided in paragraph (2) of this subsection, for a nonfreight

- 11 (a) In this section, "farm trailer or semitrailer" means a farm vehicle that is a 12 Class G (trailer) vehicle.
- 13 (b) On application, the Administration shall issue a special Class G "farm trailer 14 or semitrailer" registration to any applicant who certifies:
- 15 (1) That the applicant is a farmer; and
- 16 (2) That the vehicle for which the application is made is a farm trailer or semitrailer, specifying its proposed use.
- 18 (c) (1) Except as otherwise provided in this part, for each farm trailer or 19 semitrailer, the annual registration fee is based on the maximum gross weight limitations 20 for the vehicle, as follows:

- 27 (2) ON APPLICATION, THE ADMINISTRATION SHALL ISSUE A 28 ONE-TIME, PERMANENT SPECIAL CLASS G "FARM TRAILER OR SEMITRAILER" 29 VEHICLE REGISTRATION.
- 30 (3) THE ONE-TIME REGISTRATION FEE FOR A SPECIAL FARM 31 TRAILER OR SEMITRAILER IS BASED ON THE MAXIMUM GROSS WEIGHT, AS FOLLOWS:
- 32 MAXIMUM GROSS WEIGHT
- 33 LIMIT (IN POUNDS) FEE 34 **3,000** \$ **37.50**

- 4 (4) A VEHICLE REGISTRATION ISSUED UNDER PARAGRAPH (2) OF 5 THIS SUBSECTION IS NOT TRANSFERABLE.
- 6 (d) A vehicle registered under this section may not be used for hire except to haul 7 farm products for another farmer.
- 8 (e) A vehicle registered under this section may not be used in any manner other 9 than as a farm trailer or semitrailer.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 11 October 1, 2017.
