CHAPTER _____

1 AN ACT concerning

2 **Oil and Natural Gas – Hydraulic Fracturing – Prohibition**

3 FOR the purpose of prohibiting a person from engaging in the hydraulic fracturing of a well
4 for the exploration or production of oil or natural gas in the State; repealing a certain
5 provision of law that requires the Department of the Environment to adopt certain
6 regulations on or before a certain date; repealing a certain provision of law that
7 prohibits the Department from issuing a permit to authorize the hydraulic fracturing
8 of a well for the exploration or production of natural gas in the State until a certain
9 date; defining a certain term; and generally relating to hydraulic fracturing for the
10 exploration or production of oil and natural gas.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Environment**

4 14–107.1.

5 (a) [(1)] In this section, “hydraulic fracturing” means a [drilling technique that
6 expands existing fractures or creates new fractures in rock by injecting fluids, often a
7 mixture of water and chemicals, sand, or other substances, and often under pressure, into
8 or underneath the surface of the rock for purposes that include well drilling for the
9 exploration or production of natural gas.

10 (2) “Hydraulic fracturing” includes:

11 (i) Fracking;

12 (ii) Hydrofracking; and

13 (iii) Hydrofracturing] **STIMULATION TREATMENT PERFORMED**
14 **ON OIL AND NATURAL GAS WELLS IN LOW-PERMEABILITY OIL OR NATURAL GAS**
15 **RESERVOIRS THROUGH WHICH SPECIALLY ENGINEERED FLUIDS ARE PUMPED AT**
16 **HIGH PRESSURE AND RATE INTO THE RESERVOIR INTERVAL TO BE TREATED,**
17 **CAUSING FRACTURES TO OPEN.**

18 [(b) On or before October 1, 2016, the Department shall adopt regulations to
19 provide for the hydraulic fracturing of a well for the exploration or production of natural
20 gas in the State.

21 (c) Regulations adopted by the Department in accordance with subsection (b) of
22 this section may not become effective until October 1, 2017.

23 (d) The Department may not issue a permit for the hydraulic fracturing of a well
24 for the exploration or production of natural gas in the State until October 1, 2017.]

25 **(B) A PERSON MAY NOT ENGAGE IN THE HYDRAULIC FRACTURING OF A**
26 **WELL FOR THE EXPLORATION OR PRODUCTION OF OIL OR NATURAL GAS IN THE**
27 **STATE.**

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
29 October 1, 2017.
