## Justice Reinvestment Act - Modifications

3 FOR the purpose of requiring a certain designee who may conduct a certain assessment to 4 be certified or licensed, rather than certified and licensed; providing that a certain 5 court may grant a certain application without a hearing, but may not deny an 6 application without a hearing; authorizing a certain person serving a certain term of 7 confinement for an offense relating to drug distribution or volume dealing in cocaine 8 base imposed on or before a certain date to file a certain motion to modify or reduce 9 the sentence under certain circumstances; repealing a provision of law excluding certain sex offender registrants from eligibility for a certain geriatric parole; 10 11 repealing a certain incorrect statutory reference; altering a certain incorrect 12 statutory reference; repealing a requirement that a certain person file a certain 13 petition in a certain court under certain circumstances; altering a provision relating 14 to the expiration of the terms of certain members of the Justice Reinvestment 15 Oversight Board; making conforming changes; providing for the effective date of this 16 Act; and generally relating to justice reinvestment.
