	CHAPTER	

1 AN ACT concerning

Procurement Preferences – Blind Industries and Services of Maryland – Janitorial Products

FOR the purpose of clarifying that the requirement that a State or State aided or controlled 4 $\mathbf{5}$ entity include in certain maintenance contracts a requirement that a prime 6 contractor procure certain products from the Blind Industries and Services of 7 Maryland under certain circumstances applies to products made or, manufactured, 8 remanufactured, or assembled by the Blind Industries and Services of Maryland; providing for a delayed effective date: providing for the application of a certain 9 provision of law; and generally relating to procurement preferences related to the 10 11 Blind Industries and Services of Maryland.
