## State Personnel - Disabled Veterans - Noncompetitive Appointment

3 FOR the purpose of authorizing an appointing authority to select certain disabled veterans 4 for certain positions in the State Personnel Management System using a certain 5 selection process; requiring an appointing authority for a certain position in a unit 6 in the Executive Branch of State government with an independent personnel system 7 to develop a certain selection process for certain disabled veterans; providing that 8 certain provisions of law relating to appointments to certain positions in the State 9 Personnel Management System do not apply to the selection of certain disabled 10 veterans under certain provisions of this Act; requiring a certain appointing 11 authority to interview certain disabled veterans under certain circumstances; 12 providing that an appointing authority is not required to interview certain applicants under certain circumstances; providing for the effect of certain provisions 13 of this Act; making a conforming change; and generally relating to the appointment 14 15 of disabled veterans to positions in State government.
