A BILL ENTITLED

1 AN ACT concerning

Department of Commerce – Employment in the State's Defense Industry – Army Alliance Study

4 FOR the purpose of requiring the Department of Commerce, in conjunction with the $\mathbf{5}$ Department of Veterans Affairs and the Department of Labor, Licensing, and 6 Regulation, to conduct a study on employment in the State's defense industry; 7 specifying the minimum requirements of the study; requiring the Department of 8 Commerce to consult with certain entities; requiring the Department of Commerce 9 to report, on or before a certain date, to the General Assembly on the findings of the study; providing for the termination of this Act; and generally relating to a study on 10 11 employment in the State's defense industry.

12 Preamble

13 WHEREAS, The State is home to twelve major military installations and twenty 14 military facilities; and

WHEREAS, The State is also home to a number of defense industry organizations who, as major employers, provide substantial economic benefit to the State, accounting for almost one–fifth of the Maryland economy; and

18 WHEREAS, The workforce required to support these organizations, both public and 19 private, is highly specialized and often requires a security clearance; and

WHEREAS, The personal income tax structure of the State may affect the availability of qualified employees for the State's defense industry, including employees with experience in cybersecurity matters; now, therefore,

4 (d) On or before December 31, 2017, the Department of Commerce shall report to 5 the General Assembly, in accordance with § 2–1246 of the State Government Article, the 6 findings of the study required under subsection (a) of this section.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
1, 2017. It shall remain effective for a period of 1 year and, at the end of June 30, 2018,
with no further action required by the General Assembly, this Act shall be abrogated and
