## 2 Unemployment Insurance – Eligibility for Benefits – Business Operation 3 Closings

- FOR the purpose of authorizing the Secretary of Labor, Licensing and Regulation to exempt
  employees of an employer that closes its business operations or part of its business
  operations for certain periods of time for certain purposes from the requirement to
  actively seek work during that period to be eligible to receive unemployment
  insurance benefits; providing that a certain exemption may be granted only with
  respect to a specific business operation closing; and generally relating to eligibility
  for unemployment insurance benefits during business operation closings.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
   That the Laws of Maryland read as follows:

#### SENATE BILL 17

1 (a) When an employer closes its entire plant, **BUSINESS OPERATION**, [or] part 2 of its plant, **OR PART OF ITS BUSINESS OPERATION** for inventory, vacation, or another 3 purpose that will cause unemployment for a definite period not exceeding 10 weeks, the 4 Secretary may exempt employees of the [plant] **EMPLOYER** from the requirement of § 5 8–903(a)(1)(iii) of this subtitle to actively seek work during that period if the Secretary finds 6 that circumstances and labor market conditions justify the exemption.

6) Whenever an employer closes its entire plant, BUSINESS OPERATION, [or] part of its plant, OR PART OF ITS BUSINESS OPERATION for a purpose other than inventory or vacation that will cause unemployment for a definite period not exceeding 26 weeks, for the period of the specific shutdown, the Secretary may exempt employees of the [plant] EMPLOYER from the requirement of § 8–903(a)(1)(iii) of this subtitle to actively seek work if:

(1) the employer and affected employees jointly request the exemption;

14 (2) the employer provides that all affected employees shall return to work 15 for the employer within 26 weeks; and

16 (3) the Secretary determines that the exemption will promote productivity 17 and economic stability within the State.

18 (c) (1) This subsection does not exempt an individual from meeting the 19 requirements of § 8–902(a) or § 8–903(a)(1)(i) and (ii) of this subtitle to be able to work and 20 otherwise fully available for work.

(2) An exemption under this section may be granted only with respect to a
 specific plant OR BUSINESS OPERATION closing.
