BY adding to Article – Labor and Employment Section 8–206(i) Annotated Code of Maryland (2016 Replacement Volume) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Labor and Employment 8-206.IN THIS SUBSECTION THE FOLLOWING WORDS HAVE THE (I)**(1)** (I)MEANINGS INDICATED.
