- 6 (v) whenever practicable, be selected and arranged to avoid architectural and other barriers that impede access or voting by elderly and physically disabled voters.
- 9 (3) (i) The public official responsible for the use of any public building 10 requested by a local board for a polling place shall make available to the local board, without 11 charge, the space that is needed in the building for the proper conduct of an election.
- 12 (ii) Light, heat, and custodial and janitorial services for the space shall be provided to the local board without charge.
- 14 (iii) 1. Subject to subsubparagraph 2 of this subparagraph, 15 electioneering shall be allowed on the premises of the public building up to the electioneering boundary established under § 16–206(b) of this article.
- 17 2. Campaign signs shall be allowed on the premises of the public building, at a minimum, from:
- A. 7 p.m. the day immediately preceding election day until 8 a.m. on the day immediately following election day; and
- B. 7 p.m. the day before an early voting period begins under 10–301.1 of this title until 8 a.m. the day after the early voting period ends.
- 23 (4) (i) If suitable space in a public building is not available, a local board 24 may pay a reasonable fee for the use of space in a privately owned building.
- 25 (ii) A polling place may not be located in a privately owned building 26 unless the owner of the building agrees to:
- 27 1. allow electioneering on the premises up to the 28 electioneering boundary established under § 16–206(b) of this article; and
- 29 allow campaign signs on the premises, at a minimum, 30 from:
- A. 7 p.m. the day immediately preceding election day until 8 a.m. on the day immediately following election day; and

- B. 7 p.m. the day before an early voting period begins under 2 § 10–301.1 of this title until 8 a.m. the day after the early voting period ends.
- 3 (iii) Except as provided in subparagraphs (iv) and (v) of this 4 paragraph, an election may not be held in any building or part of any building used or occupied by an establishment that holds an alcoholic beverages license.
- 6 (iv) An election may be held in a building that is owned and occupied 7 by an establishment that holds an alcoholic beverages license if:
- 8 1. the local board determines that there is no suitable 9 alternative place to hold an election;
- 10 2. the licensee agrees not to sell or dispense alcoholic 11 beverages during the period beginning 2 hours before the polls open and ending 2 hours 12 after the polls close; and
- 3. where applicable, all ballots are removed from the polling place by the local board immediately following the election.
- 15 (v) An early voting center may be located in a building that is 16 partially occupied by an establishment that holds an alcoholic beverages license if:
- 17 1. the State Board, in collaboration with a local board, determines that the building is a suitable site for an early voting center; and
- the entrance to a licensee's establishment is at least 100 feet from the entrance to the building that is closest to the part of the building where the early voting center is located.
- 22 (5) If a polling place is located in a building owned or leased by a volunteer 23 fire company or rescue squad, the volunteer fire company or rescue squad may require the 24 local board to pay for the use of the space that is needed in the building for the proper 25 conduct of any election.
- 26 (B) (1) IN THIS SUBSECTION, "SENIOR INSTITUTION OF HIGHER 27 EDUCATION" MEANS AN INSTITUTION OF POSTSECONDARY EDUCATION THAT 28 GENERALLY LIMITS ENROLLMENT TO GRADUATES OF SECONDARY SCHOOLS AND 29 AWARDS DEGREES AT THE BACCALAUREATE OR GRADUATE LEVEL.
- 30 (2) CONSISTENT WITH THE REQUIREMENTS ESTABLISHED UNDER SUBSECTION (A) OF THIS SECTION, A LOCAL BOARD SHALL DESIGNATE AT LEAST ONE POLLING PLACE AT EACH SENIOR INSTITUTION OF HIGHER EDUCATION IN THE COUNTY THAT HAS RESIDENTIAL STUDENT HOUSING ON ITS CAMPUS.

- [(b)] (C) (1) (i) In Baltimore City, public buildings shall be used for polling places to the greatest extent feasible.
- 3 (ii) For rental of privately owned polling places in Baltimore City, 4 the local board shall pay an amount as determined in the ordinance of estimates, provided 5 that the amount is uniform on a citywide basis.
- 6 (2) In Charles County, the local board may use private firehouses, private 7 halls, and other buildings for polling places.
- 8 (3) In Montgomery County, the County Board of Education shall make 9 available the space and custodial service as needed for the proper conduct of elections upon 10 application by the local board.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2017.
