CHAPTER _____

1 AN ACT concerning

2 **Task Force to Study Bicycle Safety on Maryland Highways**

3 FOR the purpose of establishing the Task Force to Study Bicycle Safety on Maryland
4 Highways; providing for the composition, chair, and staffing of the Task Force;
5 prohibiting a member of the Task Force from receiving certain compensation, but
6 authorizing the reimbursement of certain expenses; requiring the Task Force to
7 study and make recommendations on certain issues related to bicycle safety on
8 highways in the State; requiring the Task Force to report its findings and
9 recommendations to the Governor and the General Assembly on or before a certain
10 date; providing for the termination of this Act; and generally relating to the Task
11 Force to Study Bicycle Safety on Maryland Highways.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

13 That:

- 1 (a) There is a Task Force to Study Bicycle Safety on Maryland Highways.
- 2 (b) The Task Force consists of the following members:
- 3 (1) two members of the Senate of Maryland, appointed by the President of
4 the Senate;
- 5 (2) two members of the House of Delegates, appointed by the Speaker of
6 the House;
- 7 (3) the Motor Vehicle Administrator, or the Administrator's designee;
- 8 (4) the State Highway Administrator, or the Administrator's designee;
- 9 (5) the Secretary of State Police, or the Secretary's designee; and
- 10 (6) the following members, appointed by the Governor:
- 11 (i) four bicycle advocates who are State residents, at least two of
12 whom represent urban or suburban areas of the State;
- 13 (ii) a representative of the motor vehicle insurance industry;
- 14 (iii) a representative of AAA Mid-Atlantic;
- 15 (iv) a representative of the Maryland Association of Counties;
- 16 (v) a representative of the Maryland Municipal League;
- 17 (vi) a representative of the Maryland Chiefs of Police Association;
18 ~~and~~
- 19 (vii) a representative of the Maryland Motor Truck Association;
- 20 *(viii) a representative of the Maryland Sheriff's Association;*
- 21 *(ix) a civil engineer with experience in the design of mixed-use*
22 *development infrastructure; and*
- 23 *(x) a traffic engineer who is familiar with mixed-use development*
24 *infrastructure and who has experience with the Maryland Manual on Uniform Traffic*
25 *Control Devices.*
- 26 (c) The Governor shall designate the chair of the Task Force.
- 27 (d) The Maryland Department of Transportation shall provide staff for the Task
28 Force.

1 (e) A member of the Task Force:

2 (1) may not receive compensation as a member of the Task Force; but

3 (2) is entitled to reimbursement for expenses under the Standard State
4 Travel Regulations, as provided in the State budget.

5 (f) The Task Force shall study and make recommendations it considers necessary
6 regarding:

7 (1) safety issues related to bicycle operators on highways in the State;

8 (2) the appropriate operation of bicycles on highways in the State;

9 (3) the appropriate operation of motor vehicles in relation to bicycles on
10 highways in the State;

11 (4) the adequacy of the current and future capacity and use of bike lanes,
12 bike paths, and protected cycle tracks in the State;

13 (5) past, current, and future implementation of Complete Streets
14 strategies related to facilitating safe travel for all bicyclists regardless of age, ability, or
15 mode of travel;

16 (6) issues related to traffic control devices governing the operation of and
17 behavior towards bicycles on highways in the State;

18 (7) public education and outreach related to the operation of bicycles on
19 highways in the State; ~~and~~

20 (8) potential funding sources to support and encourage the safe operation
21 of bicycles in the State;

22 (9) the effects of bike lanes, bike paths, and protected cycle tracks on street
23 parking and pedestrian and vehicular traffic flow;

24 (10) the siting of utilities and other infrastructure along bike lanes, bike
25 paths, and protected cycle tracks; and

26 (11) best practices for ensuring access to retail, residential, commercial, and
27 other points of interest adjacent to bike lanes, bike paths, and protected cycle tracks.

28 (g) On or before December 31, 2017, the Task Force shall report its findings and
29 recommendations to the Governor and, in accordance with § 2-1246 of the State
30 Government Article, the General Assembly.

SENATE BILL 142

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
2 1, 2017. It shall remain effective for a period of 1 year and, at the end of May 31, 2018, with
3 no further action required by the General Assembly, this Act shall be abrogated and of no
4 further force and effect.
