CHAPTER
AN ACT concerning
Vehicle Laws - School Bus Monitoring Cameras - Civil Penalty
FOR the purpose of altering the civil penalty for a violation recorded by a school bus monitoring camera for failure to stop for a school vehicle operating alternately flashing red lights; requiring the Montgomery County Department of Police to report to the General Assembly on or before a certain date; providing for the termination of this Act; repealing a requirement that the District Court prescribe a certain civil penalty; and generally relating to civil penalties for violations recorded by school bus monitoring cameras.
BY repealing and reenacting, without amendments, Article – Transportation Section 21–706 and 21–706.1(a)(6) Annotated Code of Maryland

AND BE IT FURTHER ENACTED, That, on or before December 1, 2018, the Montgomery County Department of Police shall report to the General Assembly, in accordance with § 2–1246 of the State Government Article, on the total number of violations recorded by school bus monitoring cameras in Montgomery County after the effective date of this Act, the effect of this Act on the frequency of violations in Montgomery County, and the number of violations recorded in Montgomery County for vehicles travelling in the opposite direction of school buses on multilane highways with painted medians.

It shall remain effective for a period of 2 years and, at the end of June 30, 2019, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.
