Subsection (e)(2) of the former law established a duty for a second or subsequent violation in a calendar year that any excess weight be unloaded before moving the vehicle. Section 27–101(1) of this article provided enhanced penalties for failure to unload excess perishable goods under subsection (e)(2) of the former law (the only provision of subsection (e) that imposed a duty on the driver). Thus, a person must fail to meet both conditions under subsection (e)(1) and (2) before a duty is imposed. 


