- 6 (ii) the annual cost of emergency room visits for dental health care 7 treatment for chronic dental conditions by zip code and county;
- 8 (2) evaluate whether there may be underreporting of dental-related 9 diagnoses in the emergency room utilization data from the Health Services Cost Review 10 Commission; and
- 11 (3) identify methods to improve the reporting and analysis of the data 12 relating to utilization of emergency rooms for treatment of dental conditions.

(c) (1) On or before December 1, 2017, the Department shall Coalition may
 report to the General Assembly, in accordance with § 2–1246 of the State Government
 Article, Department of Health and Mental Hygiene and the General Assembly the findings
 of the study conducted under subsection (a) of this section.
