(f) If a provision of this subtitle requiring notice to be provided to a party expressly requires verification or acknowledgment of receipt of the notice, the notice may be delivered by electronic means only if the method used provides for verification or acknowledgment of receipt.

(g) The legal effectiveness, validity, or enforceability of any contract or policy of
insurance executed by a party may not be denied solely because of the failure to obtain
electronic consent or confirmation of consent of the party in accordance with subsection
(d)(3)(ii) of this section.

29 (h) (1) A withdrawal of consent by a party does not affect the legal 30 effectiveness, validity, or enforceability of a notice delivered by electronic means to the 31 party before the withdrawal of consent is effective.

32 (2) A withdrawal of consent by a party is effective within a reasonable 33 period of time after receipt of the withdrawal by the insurer.

34 (3) Failure to comply with subsection (d)(4) of this section may be treated,
35 at the election of the party, as a withdrawal of consent for purposes of this section.

1 (i) This section does not apply to a notice delivered by an insurer in an electronic 2 form before October 1, 2011, to a party who, before October 1, 2011, has consented to receive 3 notice in an electronic form otherwise allowed by law.

4 (j) If the consent of a party to receive notice in an electronic form is on file with 5 an insurer before October 1, 2011, the insurer shall notify the party of:

6 (1) the notices that may be delivered by electronic means under this 7 section; and

8 (2) the party's right to withdraw consent to have notices delivered by 9 electronic means.

10 (k) (1) Except as otherwise provided by law, if an oral communication or a 11 recording of an oral communication can be reliably stored and reproduced by an insurer, 12 the oral communication or recording may qualify as a notice delivered by electronic means 13 for purposes of this section.

14 (2) If a provision of this subtitle requires a signature or record to be 15 notarized, acknowledged, verified, or made under oath, the requirement is satisfied if the 16 electronic signature of the person authorized to perform those acts, together with all other 17 information required to be included by the provision, is attached to or logically associated 18 with the signature or record.

19 (l) This section may not be construed to modify, limit, or supersede the provisions 20 of the federal Electronic Signatures in Global and National Commerce Act relating to the 21 use of an electronic record to provide or make available information that is required to be 22 provided or made available in writing to a party.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 24 October 1, 2017.
