1 (X) "SEX TRAFFICKING" MEANS THE RECRUITMENT, HARBORING, 2 TRANSPORTATION, PROVISION, OBTAINING, PATRONIZING, OR SOLICITING OF A 3 CHILD FOR THE PURPOSE OF A COMMERCIAL SEX ACT.

4 [(x) (1)] (Y) "Sexual abuse" means any act that involves [sexual molestation 5 or exploitation of a child by]:

- 6 (1) SEXUAL MOLESTATION OR EXPLOITATION OF A CHILD BY a parent 7 or other person who has permanent or temporary care or custody or responsibility for 8 supervision of a child, or by any household or family member; OR

10[(2)] (Z)["Sexual abuse"] "SEXUAL MOLESTATION OR EXPLOITATION"11includes:

[(i)] (1) allowing or encouraging a child to engage in:

- 13[1.] (I)obscene photography, films, poses, or similar14activity;
- 15 [2.] (II) pornographic photography, films, poses, or similar 16 activity; or
- 17 [3.] (III) prostitution;
