A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Cigar Shop Licenses**

3 FOR the purpose of establishing a cigar shop beer, wine, and liquor license in Frederick
4 County; authorizing the Board of License Commissioners to issue the license to a
5 certain establishment; specifying that the license authorizes the license holder to sell
6 beer, wine, and liquor to a cigar shop customer for consumption in the smoking room
7 of the cigar shop; prohibiting the average daily receipts from the sale of alcoholic
8 beverages at the cigar shop from exceeding a certain amount; prohibiting the
9 transfer of the license to another location; providing that the license holder is subject
10 to certain alcohol awareness training requirements; providing for an annual fee; and
11 generally relating to alcoholic beverages licenses in Frederick County.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
23 That the Laws of Maryland read as follows:

24 **Article – Alcoholic Beverages**

3 (A) **THERE IS A CIGAR SHOP BEER, WINE, AND LIQUOR LICENSE.**

4 (B) **THE BOARD MAY ISSUE THE LICENSE FOR USE BY AN ESTABLISHMENT**
5 **COMMONLY KNOWN AS A CIGAR SHOP THAT DERIVES AT LEAST 70% OF ITS REVENUE,**
6 **MEASURED BY AVERAGE DAILY RECEIPTS, FROM THE SALE OF CIGARS.**

7 (C) **THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER, WINE,**
8 **AND LIQUOR TO A CIGAR SHOP CUSTOMER FOR CONSUMPTION IN THE SMOKING**
9 **ROOM OF THE CIGAR SHOP DURING NORMAL BUSINESS HOURS.**

10 (D) **THE AVERAGE DAILY RECEIPTS FROM THE SALE OF ALCOHOLIC**
11 **BEVERAGES AT THE CIGAR SHOP MAY NOT EXCEED 17% OF AVERAGE DAILY**
12 **RECEIPTS OF THE BUSINESS.**

13 (E) **THE LICENSE MAY NOT BE TRANSFERRED TO ANOTHER LOCATION.**

14 (F) **THE LICENSE HOLDER IS SUBJECT TO THE ALCOHOL AWARENESS**
15 **TRAINING REQUIREMENTS UNDER § 4-505 OF THIS ARTICLE.**

16 (G) **THE ANNUAL LICENSE FEE IS \$500.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
18 1, 2017.
