Public Senior Higher Education Institutions – Financial Aid – Reduction Restrictions

FOR the purpose of regulating how public senior higher education institutions may adjust 4 5 funds awarded by the institution when the total amount of financial aid awarded to 6 a student exceeds the student's demonstrated financial need; authorizing financial 7 aid awarded by a public senior higher education institution to be reduced only under 8 certain circumstances; and up to a certain amount; prohibiting financial aid awarded 9 by a public senior higher education institution from being reduced under certain 10 circumstances: requiring certain financial aid to be reduced in a specific order: authorizing financial aid awarded by a public senior higher education institution to 11 12 be reduced up to a certain amount under certain circumstances; defining certain 13 terms; providing for the construction of this Act; making the provisions of this Act severable; and generally relating to financial aid at public senior higher education 14 15 institutions.
