Natural Resources – Protection and Restoration of State-Owned Lakes

3 FOR the purpose of establishing the State Lakes Protection and Restoration Fund as a 4 special, nonlapsing fund; specifying the purpose of the Fund; requiring the Secretary 5 of Natural Resources to administer the Fund; requiring the State Treasurer to hold 6 the Fund and the Comptroller to account for the Fund; specifying the contents of the 7 Fund; specifying the purpose for which the Fund may be used; requiring interest 8 earnings of the Fund to be credited to the Fund; requiring the Department of Natural 9 Resources to develop a certain budget; requiring the Department to develop, in 10 coordination with local governments, organizations, and citizens, a certain annual 11 work plan; exempting the Fund from a certain provision of law requiring interest earnings on State money to accrue to the General Fund of the State; defining a 12 13 certain term; and generally relating to the protection and restoration of State-owned 14 lakes.

- 7 (I) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE 8 WITH THE STATE BUDGET.
- 9 (J) MONEY EXPENDED FROM THE FUND FOR THE PROTECTION OR 10 RESTORATION OF STATE-OWNED LAKES IS SUPPLEMENTAL TO AND IS NOT 11 INTENDED TO TAKE THE PLACE OF FUNDING THAT WOULD OTHERWISE BE 12 APPROPRIATED FOR THE PROTECTION OR RESTORATION OF STATE-OWNED LAKES.

- 14 (A) THE DEPARTMENT SHALL DEVELOP A WORKING BUDGET FOR THE 15 FUNDS RECEIVED FROM THE STATE LAKES PROTECTION AND RESTORATION FUND 16 ESTABLISHED UNDER § 8–205 OF THIS SUBTITLE.
- 17 (B) THE DEPARTMENT SHALL DEVELOP, IN COORDINATION WITH LOCAL
 18 GOVERNMENTS, ORGANIZATIONS, AND CITIZENS, AN ANNUAL WORK PLAN THAT
 19 PRIORITIZES AND DETAILS PROJECTS THAT WILL RECEIVE FUNDING FROM THE
 20 STATE LAKES PROTECTION AND RESTORATION FUND.

- (a) (2) (i) Notwithstanding any other provision of law, and unless inconsistent with a federal law, grant agreement, or other federal requirement or with the terms of a gift or settlement agreement, net interest on all State money allocated by the State Treasurer under this section to special funds or accounts, and otherwise entitled to receive interest earnings, as accounted for by the Comptroller, shall accrue to the General Fund of the State.
