## Corporations - Formation of a Holding Company by Merger

3 FOR the purpose of establishing a process for the formation of a certain holding company through the merger of a Maryland parent corporation with or into a certain wholly 4 5 owned subsidiary of the Maryland parent corporation; providing that a vote of the 6 stockholders of the parent corporation is not necessary to authorize the merger under 7 certain circumstances, unless the charter of the parent corporation expressly 8 provides otherwise; requiring that the merger be approved by a majority of the entire 9 board of directors of the parent corporation; establishing the conditions under which 10 the merger may be effectuated; establishing the effects of the merger; authorizing a 11 merger of a parent real estate investment trust into a certain subsidiary real estate 12 investment trust to be approved in a certain manner, under certain circumstances; 13 defining a certain term; and generally relating to the establishment of a process for forming a holding company through a merger. 14

- 33 IMMEDIATELY PRIOR TO THE EFFECTIVE TIME OF THE MERGER, OTHER THAN:

- 1 (I) PROVISIONS, IF ANY, REGARDING THE INCORPORATOR OR
- 2 INCORPORATORS, THE PRINCIPAL OFFICE, THE RESIDENT AGENT, AND THE INITIAL
- 3 BOARD OF DIRECTORS;
- 4 (II) PROVISIONS AUTHORIZED UNDER § 2–605 OF THIS
- 5 ARTICLE; AND
- 6 (III) ANY AMENDMENT TO THE CHARTER THAT WAS NECESSARY
- 7 TO EFFECT A CHANGE, EXCHANGE, RECLASSIFICATION, SUBDIVISION,
- 8 COMBINATION, OR CANCELLATION OF STOCK, IF THE CHANGE, EXCHANGE,
- 9 RECLASSIFICATION, SUBDIVISION, COMBINATION, OR CANCELLATION OF STOCK
- 10 HAS BECOME EFFECTIVE;
- 11 (5) AS A RESULT OF THE MERGER, THE PARENT CORPORATION OR ITS
- 12 SUCCESSOR BECOMES A DIRECT OR INDIRECT WHOLLY OWNED SUBSIDIARY

- 3 ARTICLE, A PROXY AUTHORIZED BY § 2-507 OF THIS ARTICLE, OR ANY OTHER
- 4 SIMILAR AGREEMENT OR INSTRUMENT APPLIED TO THE PARENT CORPORATION, ITS
- 5 STOCK, OR ITS STOCKHOLDERS IMMEDIATELY PRIOR TO THE EFFECTIVE TIME OF
- 6 THE MERGER, THE VOTING TRUST AGREEMENT, WRITTEN AGREEMENT, PROXY, OR
- 7 OTHER SIMILAR AGREEMENT OR INSTRUMENT SHALL APPLY TO THE HOLDING
- 8 COMPANY, ITS STOCK, AND ITS STOCKHOLDERS;
- 9 (3) TO THE EXTENT THAT THE RESTRICTIONS UNDER § 3–602 OF THIS
- 10 TITLE APPLIED TO THE PARENT CORPORATION AND THE STOCKHOLDERS OF THE
- 11 PARENT CORPORATION IMMEDIATELY PRIOR TO THE EFFECTIVE TIME OF THE
- 12 MERGER:
- 13 (I) THE RESTRICTIONS SHALL APPLY TO THE HOLDING
- 14 COMPANY AND THE STOCKHOLDERS OF THE HOLDING COMPANY IMMEDIATELY
- 15 AFTER THE EFFECTIVE TIME OF THE MERGER AS THOUGH THE HOLDING COMPANY
- 16 WAS THE PARENT COMPANY;
- 17 (II) FOR PURPOSES OF § 3–602 OF THIS TITLE, ALL SHARES OF
- 18 STOCK OF THE HOLDING COMPANY ACQUIRED IN THE MERGER SHALL BE DEEMED
- 19 TO HAVE BEEN ACQUIRED AT THE TIME THAT THE SHARES OF STOCK OF THE PARENT
- 20 CORPORATION CONVERTED IN THE MERGER WERE ACQUIRED; AND
- 21 (III) 1. ANY STOCKHOLDER THAT IMMEDIATELY PRIOR TO
- 22 THE EFFECTIVE TIME OF THE MERGER WAS NOT AN INTERESTED STOCKHOLDER, AS
- 23 DEFINED IN § 3-601 OF THIS TITLE, DOES NOT, SOLELY BY REASON OF THE MERGER,
- 24 BECOME AN INTERESTED STOCKHOLDER OF THE HOLDING COMPANY; AND
- 25 2. Any stockholder that immediately prior to
- 26 THE EFFECTIVE TIME OF THE MERGER WAS AN INTERESTED STOCKHOLDER, AS
- 27 DEFINED IN § 3-601 OF THIS TITLE, REMAINS AN INTERESTED STOCKHOLDER OF
- 28 THE HOLDING COMPANY:
- 29 (4) TO THE EXTENT THAT, IMMEDIATELY PRIOR TO THE EFFECTIVE
- 30 TIME OF THE MERGER, ANY APPROVAL BY THE STOCKHOLDERS OF THE PARENT
- 31 CORPORATION UNDER § 3-702(A) OF THIS TITLE APPLIED TO THE PARENT
- 32 CORPORATION AND ANY CONTROL SHARES OF THE PARENT CORPORATION, THE
- 33 APPROVAL SHALL APPLY TO THE HOLDING COMPANY AND ANY CONTROL SHARES OF
- 34 THE HOLDING COMPANY IMMEDIATELY AFTER THE EFFECTIVE TIME OF THE
- 35 MERGER AS IF THE HOLDING COMPANY WERE THE PARENT CORPORATION;

- 1 (5) TO THE EXTENT THAT, IMMEDIATELY PRIOR TO THE EFFECTIVE
  2 TIME OF THE MERGER, THE BOARD OF DIRECTORS OF THE PARENT CORPORATION
  3 HAD ELECTED BY RESOLUTION TO BE SUBJECT TO OR NOT TO BE SUBJECT TO,
  4 WHOLLY OR PARTLY, ANY OR ALL PROVISIONS OF SUBTITLE 8 OF THIS TITLE, THE
  5 ELECTION SHALL APPLY TO THE HOLDING COMPANY IMMEDIATELY AFTER THE
  6 EFFECTIVE TIME OF THE MERGER AS IF THE HOLDING COMPANY WERE THE PARENT
  7 CORPORATION;
- 8 **(6)** UNLESS THE BOARD OF DIRECTORS OF THE HOLDING COMPANY HAS AUTHORIZED SHARES OF STOCK OF THE HOLDING COMPANY TO BE ISSUED 9 WITHOUT CERTIFICATES, OR UNTIL CERTIFICATES WITH THE NAME OF THE 10 HOLDING COMPANY HAVE BEEN ISSUED, THE SHARES OF STOCK OF THE HOLDING 11 12 COMPANY INTO WHICH THE SHARES OF STOCK OF THE PARENT CORPORATION ARE CONVERTED IN THE MERGER MAY CONTINUE TO BE REPRESENTED BY THE STOCK 13 14 CERTIFICATES THAT PREVIOUSLY REPRESENTED SHARES OF STOCK OF THE PARENT 15 **CORPORATION; AND**
