 22 FOR EACH PROGRAM PARTICIPANT;

1 **(2) TO BE ELIGIBLE FOR SELECTION UNDER PARAGRAPH (1) OF THIS**
2 **SUBSECTION, A NONPROFIT ENTITY MUST:**

3 **(I) BE BASED IN THE STATE;**

4 **(II) SERVE THE NEEDS OF THE VETERAN POPULATION IN THE**
5 **STATE; AND**

6 **(III) GENERATE ITS OWN REVENUE AND REINVEST THE**
7 **PROCEEDS OF THAT REVENUE IN THE GROWTH AND DEVELOPMENT OF ITS**
8 **PROGRAMS.**

9 **(E) (1) A NONPROFIT TRAINING ENTITY MAY DISQUALIFY A PROGRAM**
10 **PARTICIPANT FROM PARTICIPATION IN THE PROGRAM IF THE NONPROFIT**
11 **TRAINING ENTITY DETERMINES THAT THE PROGRAM PARTICIPANT'S INVOLVEMENT**
12 **IN THE PROGRAM:**

13 **(I) PRESENTS A DANGER TO THE PROGRAM PARTICIPANT'S**
14 **MENTAL OR PHYSICAL WELLBEING;**

15 **(II) HAS CAUSED OR MAY POTENTIALLY CAUSE HARM TO**
16 **OTHERS, AN ANIMAL, OR PROPERTY;**

17 **(III) PRESENTS A DANGER TO THE SERVICE DOG'S OR SUPPORT**
18 **DOG'S MENTAL OR PHYSICAL WELL-BEING; OR**

19 **(IV) DOES NOT MEET THE TRAINING REQUIREMENT OF THE**
20 **NONPROFIT.**

21 **(2) A PROGRAM PARTICIPANT MAY DISCONTINUE INVOLVEMENT IN**
22 **THE PROGRAM FOR ANY REASON.**

23 **(F) (1) THERE IS A MARYLAND VETERANS SERVICE ANIMAL PROGRAM**
24 **FUND.**

25 **(2) THE DEPARTMENT SHALL USE REVENUE FROM THE FUND TO PAY**
26 **A NONPROFIT TRAINING ENTITY.**

27 **(3) REVENUE FROM THE FUND MAY BE USED ONLY TO PAY:**

28 **(I) A NONPROFIT TRAINING ENTITY; AND**

29 **(II) ADMINISTRATIVE COSTS OF THE PROGRAM.**

1 **(4) THE SECRETARY SHALL ADMINISTER THE FUND.**

2 **(5) (I) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT**
3 **SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.**

4 **(II) THE STATE TREASURER SHALL HOLD THE FUND**
5 **SEPARATELY, AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.**

6 **(6) THE FUND CONSISTS OF:**

7 **(I) REVENUE COLLECTED BY THE DEPARTMENT IN THE FORM**
8 **OF DONATIONS TO THE PROGRAM;**

9 **(II) MONEY APPROPRIATED IN THE STATE BUDGET TO THE**
10 **FUND; AND**

11 **(III) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED**
12 **FOR THE BENEFIT OF THE FUND.**

13 **(7) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND**
14 **IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.**

15 **(8) ANY INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO**
16 **THE GENERAL FUND OF THE STATE.**

17 **(9) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN**
18 **ACCORDANCE WITH THE STATE BUDGET.**

19 **(10) MONEY EXPENDED FROM THE FUND IS SUPPLEMENTAL TO AND IS**
20 **NOT INTENDED TO TAKE THE PLACE OF FUNDING THAT OTHERWISE WOULD BE**
21 **APPROPRIATED FOR THE PROGRAM.**

22 **(G) (1) FOR THE PURPOSE OF IMPLEMENTING THIS SECTION, THE**
23 **DEPARTMENT MAY ACCEPT GIFTS OR GRANTS FOR DONATION TO THE FUND.**

24 **(2) ON OR BEFORE OCTOBER 1, 2018, AND EACH OCTOBER 1**
25 **THEREAFTER, THE DEPARTMENT SHALL POST AND MAINTAIN ON ITS WEB SITE A**
26 **LIST OF THE NAMES OF THE PERSONS WHO HAVE DONATED TO THE FUND IN THE**
27 **PREVIOUS YEAR AND HAVE NOT REQUESTED ANONYMITY.**

28 **(H) THE DEPARTMENT SHALL ADOPT REGULATIONS TO IMPLEMENT THIS**
29 **SECTION, INCLUDING REGULATIONS ESTABLISHING PROCEDURES FOR THE**
30 **DEPARTMENT TO:**

7 (2) REFER ELIGIBLE VETERANS TO SELECTED NONPROFIT ENTITIES;

8 (3) RECEIVE DONATIONS FOR THE FUND THROUGH A LINK PLACED IN
9 A PROMINENT LOCATION ON THE DEPARTMENT'S WEB SITE; AND

10 (4) USE REVENUE FROM THE FUND TO PAY SELECTED NONPROFIT
11 ENTITIES FOR SERVICES THAT ARE PROVIDED THROUGH THE PROGRAM.

12 SECTION 2. AND BE IT FURTHER ENACTED, That, on or before December 31,
13 2019, the Department of Veterans Affairs shall report to the General Assembly, in
14 accordance with § 2-1246 of the State Government Article, the following information
15 regarding the Maryland Veterans Service Animal Program established under § 9-957 of
16 the State Government Article, as enacted by Section 1 of this Act:

17 (1) the number of Program participants involved in the Program;

18 (2) the nonprofit training entity or entities selected by the Department for
19 involvement in the Program;

20 (3) an accounting of the money deposited into and redeemed out of the
21 Maryland Veterans Service Animal Program Fund established under § 9-957 of the State
22 Government Article, as enacted by Section 1 of this Act; and

23 (4) any other information related to the Maryland Veterans Service Animal
24 Program that the Department considers relevant.

25 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
