1 AN ACT concerning

2 **State Government – Maryland Manual – Revisions**
3 **(Maryland Manual Modernization Act)**

4 FOR the purpose of altering certain provisions of law to require the State Archives to
5 compile, edit, and publish an online Maryland Manual; altering the content of the
6 Maryland Manual; requiring, as provided in the State budget, the State Archives to
7 update the Maryland Manual as necessary to maintain the accuracy of the
8 information and to annually preserve a version that contains certain changes;
9 requiring the State Archivist, to the extent practicable, to provide certain outreach
10 to certain persons; repealing certain provisions of law relating to the provision and
11 distribution of the Maryland Manual by the State Archivist; and generally relating
12 to the Maryland Manual.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – State Government**

4 9–1026.

5 (a) [Every 2 years, the] **THE** State Archives shall compile [and], edit [a], **AND**
6 **PUBLISH AN ONLINE** Maryland Manual that:

7 **(1) DESCRIBES:**

8 **(I) THE STATE AND ITS GOVERNMENT, INCLUDING STATE,**
9 **INTERSTATE, REGIONAL, COUNTY, INTERCOUNTY, AND MUNICIPAL GOVERNMENT;**
10 **AND**

11 **(II) FEDERAL OFFICIALS AND AGENCIES DIRECTLY RELATED TO**
12 **THE STATE; AND**

13 **(2) contains:**

14 **[(1)] (I) a copy of the Maryland Constitution;**

15 **[(2)] (II) the name [and address] of each officer of the State [or], a county,**
16 **OR A MUNICIPALITY** who is:

17 **[(i)] 1. elected;**

18 **[(ii)] 2. appointed by the Governor; or**

19 **[(iii)] 3. appointed by the Board of Public Works; and**

20 **[(3)] (III) any other information that, in consultation with the Hall of**
21 **Records Commission, the State Archivist considers necessary.**

22 **[(b) In accordance with Division II of the State Finance and Procurement Article,**
23 **the Archives shall print the Maryland Manual, as provided in the State budget.]**

24 **(B) AS PROVIDED IN THE STATE BUDGET, THE STATE ARCHIVES SHALL:**

25 **(1) UPDATE THE MARYLAND MANUAL AS NECESSARY TO MAINTAIN**
26 **THE ACCURACY OF THE INFORMATION; AND**

1 **(2) ANNUALLY PRESERVE A VERSION OF THE MARYLAND MANUAL**
2 **THAT CONTAINS ALL CHANGES MADE TO THE MARYLAND MANUAL UNDER ITEM (1)**
3 **OF THIS SUBSECTION IN THE IMMEDIATELY PRECEDING YEAR.**

4 **(C) TO THE EXTENT PRACTICABLE, THE STATE ARCHIVIST SHALL PROVIDE**
5 **OUTREACH TO PUBLIC SCHOOLS, PUBLIC LIBRARIES, AND THE GENERAL PUBLIC TO**
6 **INCREASE AWARENESS REGARDING THE AVAILABILITY AND CONTENT OF THE**
7 **MARYLAND MANUAL.**

9 (a) The State Archivist shall provide, without charge:

10 (1) to the State Law Library, 25 cloth-bound copies of each new Maryland
11 Manual;

12 (2) to each member of the General Assembly, 2 cloth-bound copies and 8
13 other copies of each new Maryland Manual;

14 (3) to each public or private educational institution in the State, 1 copy of
15 each new Maryland Manual; and

16 (4) to the Legislative Library, 50 cloth-bound copies of each new Maryland
17 Manual.

18 (b) If a former member of the General Assembly asks the State Archivist for a
19 copy of the Maryland Manual, the State Archivist shall provide, without charge, a copy of
20 the current Maryland Manual.

21 (c) The State Archivist and the Secretary of State may distribute other copies of
22 the Maryland Manual as they consider necessary or desirable.]

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2017.
